
As Warriors, we will strive for excellence.

Player Conduct:

- 1. I will strive to perform each aspect of the game to the highest level of my ability and with the highest level of integrity.
- 2. I will support my team and teammates at all times.
- 3. I will respect all coaches, opponents', and referees at all times.
- 4. I will be responsible for my behavior on and off the court. I will remember all of my actions can either affect my team positively or negatively.
- 5. Teamwork is not a preference, it is a requirement Encourage one another.
- 6. Missing or late arrivals to practice/games will not be tolerated.
 - I will arrive to practice/games on time/early, and be ready to start.
 - It is my responsibility to inform my coaches if I will be late or absent. Understanding that this will affect playing time
- 7. I will practice good sportsmanship at all times, to win without boasting, to lose without excuse and never guit.
- 8. I understand that violence/abuse of any nature will not be tolerated at any time.
- 9. I understand that playing time is earned in practice, through skill set, basketball IQ, work ethic, and Code of Conduct agreement. No one is guaranteed to play.

Parent Conduct:

- 1. I will understand the purpose of our program is to help our boys become men of empathy and integrity who will lead, be responsible, and change the world for good.
- 2. I will agree to cheer, let the coaches coach, the referees ref and the players play.
- 3. I will respect coaching decisions regarding playing time, position, and placement.
- 4. I will not approach coaches before, during, or after games. If there is a need to meet, I will do the following:
 - First, to promote self-advocacy, I will encourage my player to speak with the coaching staff,
 - I will surprise my player at practice to get a better understanding of skill, urgency, and dedication.
 - The last step would be to schedule a meeting with the coaching staff. A meeting
 must be scheduled, so concerns can be addressed in an atmosphere conductive
 to problem solving. Playing time or other student-athletes will not be open for
 discussion.
 - I will not approach coaches before, during or after a game concerning playing time.





- 5. I will be a positive role model.
- 6. I will never ridicule or yell at my child or other participants for making a mistake or losing a competition.
- 7. I understand in order for my player to be a member of the NAHS basketball team, all fees must be paid. *
- 8. I will support the North Atlanta Warriors basketball team and the coaches.
- 9. I will arrive at a timely manner to pick my child up from practices and games.

Coaches Conduct:

- 1. I will strive to perform my duty to the highest level possible, and be a role model for all student athletes.
- 2. Coaches will provide encouragement and will be constructive with all criticism.
- 3. I will provide an atmosphere of teamwork and collaboration among players, parents, and other coaches.
- 4. There will be a coach at the gym at least 30 minutes prior to all practices.
- 5. Coaches give playing time based on skill, level, practice time, performance, work ethic, sportsmanship, and the code of conduct agreement.
- 6. Coaches will stay with a player on all away games until a parent has picked their student up.

Discipline Policy/Consequences:

Each player and parent is advised of the following discipline policy and consequences for any and all inappropriate conduct.

- 1. Any and all disciplinary action shall be reviewed by the coaching staff.
- 2. Any and all actions may include but are not limited to the following repercussions (some violations can go straight to b or c):
 - a. Verbal Warning
 - b. Suspension
 - c. Dismissal from the program*
- 3. Some violations may go straight to b or c, any/all violations can affect playing time.

By signing this form, the player and parent both have read and understand the conduct expected for the 2017-2018 season. Both provide their consent that a player who violates the Code of Conduct may be subject to disciplinary action by their coaching staff which may affect playing time.
