



**American Youth Football League  
2023 Season Official Player Release Form**



This form must be filled out completely by the League Member and Parent/Guardian wishing to obtain permission for release from their existing League Member. The Parent/Guardian should review and initial the relevant bylaws below prior to signing the release form.

**Section 5.I.1:** Once a player registers with a League Member, the player has until on or before March 31<sup>st</sup> to move to another league member. On or After April 1<sup>st</sup> that player must remain with the registering League Member for the duration of that season, unless that player is involuntarily released (i.e. cut). **Initial** \_\_\_\_\_

**Section 5.I.3:** 'Two Move' Rule: Players can only change League Members twice during their lifetime, other than as specified in Section 5.I.4, Section Five:I.5, and Section Five:I.6. This provision is not waivable as a hardship. Sitting out one or more seasons does not 'reset' 'the move' count.

**Section 5.I.4:** A Player will be permitted a third move back to either one of their two previous parks without a hardship waiver. This move must adhere to Section Five: I.2. This will be the final move allowed for this player. **Initial** \_\_\_\_\_

**Section 5.I.5:** If a player is cut by a club and as a result elects to play for another club that season, that shall not be considered a move for the purposes of the 'Two Move' Rule. If the same player returns in a subsequent season to the club who originally cut them, that shall not be considered a move for the purposes of the 'Two Move' rule. A move to any club other than the club that originally cut the player shall be considered a move. **Initial** \_\_\_\_\_

**Section 5.I.6:** A 'cut' is defined as the involuntary removal of a player from a team, either for disciplinary or performance reasons. No league member may claim to have cut a player in order to circumvent rule 5.I.3. Misrepresentation to the AYFL Board shall be punished in accordance with the disciplinary matrix. **Initial** \_\_\_\_\_

**Section 5.I.7:** Third moves will not be allowed under any circumstances other than as specified in Section Five: I.4. **Initial** \_\_\_\_\_
