Re: Veterans Memorial Community Center Ice Rink Access Petition

Dear Sir/Madam:

We the undersigned are citizens and residents of Inver Grove Heights whose children are required to play youth hockey at Eagan Hockey Association ("EHA"). The purpose of this petition is to request that the City of Inver Grove Heights change its current ice rental policy to provide our children equal access to Veterans Memorial Community Center ice rinks' use in a fair and thoughtful manner that does not favor other Inver Grove Heights children over ours simply on account of our living in School District 196 and not School District 199.

#### **Background**

Minnesota youth hockey is governed by Minnesota Hockey, an affiliate of USA Hockey (MH).<sup>1</sup> If an Inver Grove Heights skater wants to play winter hockey outside of the MH, there are very few options across the Twin Cities' metropolitan area and no option in Inver Grove Heights.

MH Rule IV(B)(1)(a)) states that "[P]layers must register and participate with the association whose boundaries incorporate the player's residence." District 8 of MH includes Inver Grove Heights Hockey Association ("IGHHA"), EHA, Rosemount Hockey Association, Eastview Hockey Association and other associations making up portions of the southeastern metropolitan area of the Twin Cities. Each association in District 8 enters into a MH affiliate agreement setting its boundaries. Pursuant to their affiliate agreements with MH, EHA and Eastview Hockey Association have membership boundaries mirroring the boundaries of Eagan High School and Eastview High School. Thus, Eagan residents who are assigned by geographic residence to Eastview High School must play for Eastview Hockey Association. Approximately 15% of skaters residing in Eagan skate at Eastview.

Per its affiliate agreement, IGHHA allows for the registration of children residing within School District 199 boundaries – not the city boundary of Inver Grove Heights. Last year, 115 Inver Grove skaters played hockey for EHA, an increase from 48 from 2018. This number is expected to continue to grow on account of the continued development in Inver Grove Heights assigned to School District 196 and thus required EHA registration.

Further, as you may know, the portion of Inver Grove Heights in School District 196 previously assigned to Rosemount High School (and thus required to skate for the Rosemount Hockey Association, has been re-assigned to Eagan High School and thus its residents may skate only with EHA (although a grandfather rule offers current skaters the choice to remain skating with Rosemount Hockey Association). Approximately 20-30 skaters reside in that newly assigned area, which will begin increasing the number of Inver Grove Heights skaters at EHA starting this fall.

As further background, the city of Eagan makes ice time at Eagan Civic Center available to both EHA and Eastview Association in proportion to the number of residents skating at both associations. Under this policy, approximately 15% of the ice time available (including prime ice times) to Eagan residents for youth hockey (before being offered to the general market for ice time) is allotted to Eastview. While EHA could greatly use the ice allotted to Eastview Hockey Association, EHA understands the city of Eagan's decision and supports it.

Similarly, the city of Burnsville has historically apportioned ice at its municipal ice facility between the Burnsville Hockey Association and Apple Valley Association due to Apple Valley's Burnsville residents. The coop between the associations has likely changed their formulas. Until recently, the city of Plymouth provided Armstrong Hockey Association with allotted ice time due to Plymouth residents skating there (Armstrong no longer requests ice due to its fallen numbers and having sufficient ice at New Hope Ice Arena and at present, actually sells its New Hope Ice Arena ice to Wayzata Hockey Association). We are confident that there are many other cities who offer all their residents' children access to their municipal ice facilities.

It is worth understanding that the future of association hockey is not predictable. Long-standing associations like St. Paul Johnson and Minneapolis Southwest no longer exist due to their lack of skaters. St. Paul and Minneapolis thus market their ice to suburban associations as a necessity. Closer to home, the once large South St. Paul Hockey Association now cannot use their ice at Woog Ice Arena. They will not have a girls program this year and last year its boys program formed a cooperative with IGHHA. IGHHA has also experienced declines in its registration numbers in recent years. The boys' cooperative with South St. Paul Hockey Association and the girls' cooperative with EHA has presumably helped the overall experience for IGHHA members.

#### Request

The ice time allotted to Eagan Hockey Association at the Eagan Civic Center is insufficient for its skaters' needs. As a result, Eagan Hockey Association is forced to purchase ice from other ice rinks which results in our children having to frequently skate at ice arenas in St. Paul, South St. Paul, Burnsville and Mendota Heights.

We have been told that Eagan Hockey Association has requested ice from the City of Inver Grove Heights, noting its high Inver Grove Heights resident membership, however its request was politely denied without much explanation. This is unacceptable to the Inver Grove Heights taxpayers signing this petition.

While the city of Inver Grove Heights can surely perform its own research, we can state with confidence that approximately 130 children played hockey for IGHHA last year. Thus, 46% of Inver Grove Heights children playing youth hockey last year skated at EHA. Next year, an additional 20-30 skaters from Inver Grove Heights are immediately eligible to skate at Eagan Hockey Association should they choose on account of the School District 196 changes mentioned above. Additionally, EHA expects and is planning for additional growth in its Inver Grove Heights skaters on account of the surge of Inver Grove Heights housing development in its School District 196 regions. (We can largely attest to this as true considering the massive construction we all routinely deal with while these Inver Grove Heights areas develop!)

For these reasons, it is likely that next year or very soon thereafter more Inver Grove Heights children will be skating with Eagan Hockey Association than Inver Grove Heights Hockey Association. We trust the city of Inver Grove Heights desires to serve this constituency.

We hope and expect this petition and the facts and issues it raises will cause the city of Inver Grove Heights to revisit its ice availability policies at Veterans Memorial Community Center. We expect *our* city to show the same concern for our children that the city of Eagan shows its children who happen to reside in Eastview High School boundary. We trust the city of Inver Grove Heights has no intention to discriminate against our Inver Grove Heights' children on account of the arbitrary school district boundaries. We also trust the city of Inver Grove Heights has no desire to solely support residents who are currently assigned to attend Simley High School (nor could such desire serve as a rational basis for such discrimination).

As reference above, it is again worth noting that EHA and IGHHA have joined as a cooperative for their respective girls' hockey programs. The "Spartacats", as they have named the cooperative, have enjoyed the partnership for more than five years and recently expanded it to include U8 and U6 skaters (girls under 8 years old). We envision the two associations only becoming closer and more joined in the years to come and trust the city of Inver Grove Heights does not desire to oppose this through its ice availability policies.

#### **Immediate Action Item**

We request that the city schedule a meeting with our representatives in the coming weeks to discuss this matter and start a constructive dialogue. Dear Members of the Eagan Hockey Association,

Once again, it's time to officially call an end to another hockey season. I'd like to begin by once again thanking all our coaches, team managers, parent volunteers and Board members who have spent so much of their time contributing to our Association. It is because of all of you that we are able to continue to be successful in bringing the game of hockey to the youth within our community.

We began the 2022/2023 season by welcoming three new members to the Board: Kristian Thonvold, Heath Pecor, Katie Usset. And, as the year concludes, seven Directors have chosen to end their time on the Board: Chris Rasinen, Dave Karsnia, Lindsay Greenlee, Eric Gundersen, Tena Lyons, Grant Robbins, and myself. I sincerely thank all of these individuals for their years of service and long-time commitment to EHA.

The 2022/2023 season featured the first season of our Refrigerated Rink at Goat Hill Park. As with any special project without a definite template to follow, there were many learning experiences we will take into next season. We were able to extend the outdoor season for ice by about a month on both ends in relation to our normal outdoor season. We are working with the city to explore a Zamboni and heated shelter for storage as early as next year. The long-term vision is to have a pavilion cover, locker rooms, a more robust warming facility, outdoor amenities, stands, player boxes, and a scoreboard. A special thank you to Mike Larson and his team of volunteers working with the city to make the rink a huge value addition to EHA.

Results from investments in recruiting and retention continue to show. Each first-time skater is provided a full set of equipment. We create a fun environment for our 6U/8U, Mini Mites, and Mites by hosting jamborees, hot dog hockey, and an engaging active practice schedule. We hit high water marks for participants in 6U/8U, Mites, Squirts, 12U, as well as male participants, female participants, and total number of participants. For the second straight year, we hosted a Bantam send-off party to properly recognize our "graduating" class of male players.

Our charitable gambling operation, led by Sue Downey, had another extremely successful year. For fiscal year end 2022, EHA's charitable gambling operation ranked #8 in charitable proceeds in the State out of over 1100 organizations. The success of this program enables EHA to continue to invest in our association and to give back to our community through scholarships, improvements to the Eagan Civic Arena and donations to other youth and high school organizations. I want to thank Sue for all her work in running this operation.

At the end of the day, we are here to promote the growth and development of our hockey players. I can honestly say that, after four years on the board, EHA does a great job to fulfill our mission. Thanks to everyone who made my year as President and previous years of service a fun and positive experience.

## **Hockey Operations – Michael Lavine**

Throughout the season, the role of Hockey Operations has the honor of taking on a wide variety of responsibilities. From last season to this current season, our association numbers grew over 5%. We increased our travel teams count from 22 to 25 (Squirts, 10U, PeeWees, 12U, Bantams, 15U and Jr Gold) and saw a nice increase at our non-travel levels as well. Similar to previous seasons, we had many teams that did very well in tournaments and post-season play, with teams making it to regions and our 15UB1 team advancing to state.

With a growing association, one of our biggest challenges, like many associations in our areas and in the cities, is securing ice time. We always look to maintain a high number of ice touches for our teams and players. We were able to secure a number of hours at the St Thomas Arena and look to be able to partner with them in the future as well for more ice time and enjoyed the convenience of the location. And aside from the Eagan Civic Arena, we took advantage of the new outdoor refrigerated at Goat Hill (and the other outdoor rinks in the City of Eagan), and also Burnsville, Woog, Inver Grove/VMCC and the occasional sheet at one of the Ramsey County rinks.

A big focus of our pre-season planning is centered around tryouts. This year's tryout committee was composed of Hockey Operations, three additional members from the Board of Directors and three members at large, including two members who were new to the tryout committee process. Throughout our committee meetings, we discussed a number of topics and ideas in order to help improve our tryouts and team formation. We considered and implemented feedback from surveys, parents, coach input and researched how other associations across the cities and states conduct their tryouts as well. The committee also reviewed using a digital platform called TeamGenius for evaluation tracking and in-season/post-season coach feedback for player development. Our goal for tryouts, no matter what remains the same or changed, is to provide for an evaluation that is fair to all players, develops and maintains a clear process, and to continuously improve year over year.

We continue to host a tryout information session to review the overall tryout process and collect questions and feedback from the association at large. The committee continued to build on the data analysis tools available throughout the process to facilitate fair and efficient processes for team formation. As in past years, we used a variety of drills and scrimmage formats to evaluate skaters and goalies for all traveling teams.

Thank you to all the committee members for your time and dedication to help run our tryouts for all levels.

Additionally, we look for opportunities to provide training for our association members and families, especially those with younger players, for GameSheet (digital scorebook), operating the scoreboard, providing resources for managers to help coordinate their team and to find ice to fill in any gaps in their schedules if desired.

A very big thank you to our players, coaches, parents, family members, board members, volunteers, managers and everyone who played a hand in making the 2022-23 season another great one for Eagan Hockey.

## Coach-In-Chief / Player Development – Jon Kerr

We had an outstanding group of both paid and parent coaches to serve our teams this year. By leveraging as many qualified parent coaches as possible and filling in the gaps with highly qualified paid coaches, our association thrived at all levels. We held a couple coach clinics throughout the season to train the coaches and share ideas amongst our coaching staff. We also held coach exit interviews at each level to discuss any improvements that can be made for next season.

Our association moved from the AA to A level at both Peewee and Bantam five years ago with the intention of returning to AA hockey in a few years time. We made the transition from Bantam A to AA this season. While many were apprehensive about the transition initially, the team played hard and learned to compete at the top level. It was a successful transition back to the AA level for the organization.

Some changes were made at the boys mini-mite levels this season. We separated the K and 1st graders into separate groups. Goaltending was introduced to the first grade group.

The Eagan high school players occasionally surprised the mini-mites at morning practices and attended indoor/outdoor jamborees, etc. We received a lot of great feedback from parents who enjoy seeing the older kids "give back" to the younger kids. High school players were assigned to traveling teams to occasionally help out at practice and watch games. Our annual 3v3 leagues in August for the pee wee and bantam levels continued as usual. The program has been very popular and is a great way to get back on the ice before tryouts. Special thanks to the parent volunteers who helped move boards between games for the zamboni, manage the score clock and manage the bench. These volunteer efforts help keep the 3v3 league very affordable for everyone.

We continued our relationship with CoachThem (www.coachthem.com) this season. CoachThem is a tool that allows coaches to create, edit, save, and share practice plans with other coaches within their team, level, and association. CoachThem continues to be the preferred platform for MN Hockey and its associations within.

We completed our third season using the gray and green practice jerseys for all travel teams. Please hang on to these practice jerseys over the summer. It is expected that players will return their washed practice jerseys on the first day of tryouts and choose a larger sized practice jersey each season as needed. Second year bantams can keep their practice jerseys.

Erik Anderson ran a checking clinic in September for first year bantams. Attendance was optional for second year bantams and many attended. This program allows players to gain confidence with body contact in a controlled environment and was well received. Erik Anderson also continued as our skating and skills instructor working with all of our players and coaches, improving both player and coaching skills. Devenir Goaltending continued this year as our goalie instructors.

Our treadmill room and dryland rooms were both fully operational this season. We continue to partner with E-train for our treadmill instructors. There was some new stickhandling equipment added to the shooting area and new shooting tarps were installed.

Our Home Ice Advantage summer program was operated by E-train this past season and we will be using them again in 2023. The older group (squirt/U10 and up), skated 3 days per week and had one day per week of dryland at the Training Haus. The younger group (mites/mini-mites) skated two days per week. The same schedule is expected for both groups in 2023.

In summary, a very successful season for Eagan hockey both on and off the ice. Thanks to all the coaches and managers who put in a lot of hard work to make the association what it is.

## 10U/12U/15U Girls Program – Eric Gundersen

For the 2022-2023 season we had a total of 127 girls registered with the Eagan Hockey Association, in our Coop and another 32 girls in our boys program. Our numbers grew again over last year due to high numbers on the 6U level! We will continue our recruiting efforts to ensure the growth continues and also work to refine our program to maximize development for our players. This year was also the first year of the Jersey Program and our families were ecstatic to see their kids in the new jerseys and numbers. The roll out went seamless with the help of many EHA families and great communication provided by all. This was a highlight for many EHA members!!

Our 10U program continues to be managed by the IGHHA and we are looking to make changes to continue to align 10U and 12U in regards to development, tryouts, goaltender development and coaching methods. I am happy to report we achieved the goal of ice at both VMCC and Eagan, but we still have some holes to fill in other areas. This year we saw our 10U A team win the Flight B district tournament, our 10U b1 was competitive all season and our 10UB2 made the Flight A bracket in districts. As mentioned before we have room to grow in terms of the partnership at 10U and we look forward to exciting changes as the coop evolves.

The 12U program, as in years past, was managed by the Eagan Association. As with the 10U program we worked to integrate VMCC into the ice rotation. The goal of this was to allow our IGH families to continue to skate on their home ice throughout their association play. I am happy to say we achieved this goal and had a diverse spread of ice location. At 12U we also started the process of integrating EHS girls attending Skills Sessions and next season we will work to have integrated practices and other exciting initiatives. Our new EHS coach Jessica Ptachick was a part of every skill session for this group and got to know the girls coming up through the system. The goal at this level is to continue to get the girls excited for EHS Hockey and start to see what that next level is like. Our 12 U A team enjoyed a competitive season, our 12UB1 White team won the Cloquet tournament and placed 3rd or better in every tournament and our 12Ub1-Blue team placed 2nd in Owatonna and positioned for a medal in almost every tournament. Finally the 12U b2 team took second in Districts and enjoyed many triumphs through the year. Overall it was a fantastic season for our 12U girls.

15U we had a team of EHA, SSP and IGH and they fought their way to the State Tournament and competed well in the final tournament of the year. It was an amazing season for the girls and we are proud of them for representing Eagan at State. We are thankful for their partnership with SSP on this level and they were a terrific addition to the team all around!

Our girls enjoyed a special events again this year at the Women's Gopher Hockey Game where our 6U girls got to play on the ice at intermission and our whole program got tickets at a discounted price and recognition at the event. We also coordinated a St Thomas game alongside EHS and had a lunch and intro before the game with the High School Girls. We will continue to look at these opportunities and add more throughout the upcoming year as these opportunities help build the love for the sport.

For the upcoming season we will continue to work with our IGH partners and build upon the momentum we had this year. We will continue to advocate for split ice at both locations for all levels, ensuring Dryland use at the 10U level, keeping ice hours and skills development equal across all levels, consistent tryouts and coach selection, continue to search and find female coaches for our various levels, focus on goalie development and lastly create opportunities for our kids to have fun and many more initiatives.

Overall our girls program made changes we feel will enhance player development, foster a love for the sport and most importantly, help create a culture that continues to create memories and friendships for our kids that will last a lifetime!

## **6U/8U Girls Program – Christian Mondick**

For the 2022-2023 season we again saw an increase in girls joining the EHA program. There were enough girls to field 2 teams at the 6U level and 3 teams at the 8U level. Beginning numbers supported the 3 teams at 8U but with more families joining throughout the season we could have possibly had 4 teams at 8U by the end. New families joined throughout the season as our current families are our best method for our recruiting efforts of our program.

The 2022 - 2023 was the 2nd season of the 6U/8U being included in the SpartaCat Coop and was the first time that EHA provided a Girls Coordinator at that level. The organization of the 6U/8U Coop with IGH, is similar to the 10U/12U Coop where each association managed one level. 6U was managed by EHA and 8U was managed by IGH. Since the start up of 6U/8U Coop is so new, there have been learning opportunities and challenges to find a consistent experience for the girls from both associations . A lot has been learned from the last two seasons and changes will be happening in Spring/Summer of 2023 to provide a more streamlined experience for all girls at the 6U/8U level for the 2023 - 2024 season.

6U enjoyed two Jamborees hosted by EHA, with the 2nd Jamboree happening for the first time at our Outdoor Refrigerated Rink "Goat Hill". The new location was well received by all and looks to be a tradition going forward for Jamborees.

8U teams each participated in 3 Jamborees; the MN Wild Jamboree, One Hockey MN Gone Wild Girls Jamboree, Hudson WI Girls Jamboree, and the IGH Girls Hosted Ice Jamboree. Our 8U Families did have to cover the cost of a 3rd Jamboree, so will look next season to reduce or remove that fee going forward.

Our girls enjoyed special events again this year at the Women's Gopher Hockey Game where our 6U girls got to play on the ice at intermission and our whole program got tickets at a discounted price and recognition at the event. We also coordinated a St Thomas game alongside EHS and had a lunch and intro before the game with the High School Girls. We will continue to look at these opportunities and add more throughout the upcoming year as these opportunities help build the love for the sport.

## Mini Mite & Recruiting/Retention – Lindsay Greenlee

Our 2022/2023 season held up with the record breaking numbers of last season. Mini mites had 12 teams and a total of 118 kids. We split our program into Mini-Mites K for kindergartners and Mini-Mites 1 for 1st graders. This helped with the huge skill difference between the ages.

Obviously, the on-ice aspects are the focus for our Mini-Mites/6U. Another major component to the success of our younger programs is the "fun" other activities we offer our skaters. This year, we had hot dog hockey with no weather cancellations, outdoor jamboree, indoor jamboree and the end of the year party. Kids and parents alike enjoyed and raved about the fun events with great attention to detail.

We had such a large demand for our Little Wildcats program we had to split into two "sessions". We ended up with a total of 61 kids trying hockey for the first time! We had kids up to 5th grade joining and playing. We also were able to secure 100% of these kids into signing up and playing the 2022-2023 season. We were able to provide all of these kids with new free gear from Pure Hockey, which went very smoothly.

This was our fourth year for our Termites program. This is for kids who will be entering Kindergarten next year. While up from last year, we had 44 kids sign up.

We had an awesome year, players, parents and coaches were happy and enjoyed their time. Thank you to all the coaches and team managers who made this season a success.

## Mite - Christian Prouty

This past year Mites started off strong with Mite 3v3. Mite 3v3 began early August running into late September. With the strong focus on ability to participate, we had 8 teams of about 9-10 skaters per team. We played 3 cross-ice games and rotated two teams off per week.

Going into evaluations, we had determined there would be about 10 teams of skaters. We were able to provide a mite program for the 115 players who had signed up. After evaluations, we determined the grouping to be particularly strong and went with six mite-3 teams and four mite-2 teams. Initially, as ice time was a challenge, we instituted 45-minute practices with no resurfacing to enable three groupings to be on the ice. As the Goat Hill Rink came online mites had heavy use of that practice facility. During the busiest time of the season mites were able to skate on practice on Wednesday and Saturday, have Game Day on Sunday, Hot Dog Hockey on Friday as well as having an additional practice (or two) per week. On average each team had 75 ice times over the 16 week season. This led to the remarkable growth our mite players were able to achieve. Each mite 3 team was able to have a couple of out of association scrimmages and the mite 2 teams were able to scrimmage as well.

Going forward at this level it would be wise to manage the average contacts per week around five or so. Further, with the number of participants topping out over 110 (10 girls) (46 second year/64 first year)\*, it would be wise to focus volunteer efforts in the following ways:

- 1. Scrimmage Coordinator. I want to very much thank Terry Jung who modeled the tireless effort required to obtain and manage scrimmages.
- 2. Hot Dog Hockey Coordinator: A person who interfaces with team managers to arrive at a hot dog hockey schedule for each mite team. Also, can help coordinate purchasing and reimbursement from the EHA treasurer for expenses.

- 3. Game Day coordinator: Responsible for connecting with DIBS coordinator to ensure mite volunteer opportunities around gameday, hot dog hockey and mite 3v3 are posted and available for families.
- 4. Mite 3v3 coordinator: Responsible for forming mite teams and scheduling games for those teams.

#### **Squirt Program - Heath Pecor**

EHA fielded six Squirt teams during the 2022-2023 season. Each team comprised 10-13 skaters (67 skaters total) and six goalies were dispersed among the six teams. EHA went with a SA, SB1 Green, SB1 Blue, SB2, SC Green, and SC Blue

A successful in-house pre-season EHA 3on3 league in September set the tone for the official start of the season in October. Scrimmage season kicked off with EHA's annual Squirt Face-off in early November as EHA invited Prior Lake's six squirt teams to compete in the first scrimmages of the year in back-to-back ice times on the west rink. In addition to the D8 regular season and scheduled scrimmages, each squirt team participated in at least three tournaments throughout the year.

As tryouts were in progress the decision was made to form two B1 teams instead of just 1 based on results of the scores. Due to this we had 3 teams with 10 skaters and 1 goalie each, while the other 3 teams had 12-13 skaters and 1 goalie each. As an organization we learned a lot from this experience and I believe moving forward we plan to have no less than 11 skaters per team if the numbers allow it. Thank you to all the parents, coaches, managers and players for a successful season all around! We know it takes everyone playing a small part to have organized and fun seasons for the kids. Let's take a closer look at each team's results for the year.

Eagan Hockey Association was honored to win an equipment grant from Minnesota Hockey for the 2022-2023 season. The grant in partnership with Dick's Sporting Goods helped the association grow our reserves of new equipment including shoulder pads, gloves, breezers, and elbow pads for our youngest players.

EHA's Junior Gold program added a third team this season. The board decided to add new uniforms for players who have been with us for many years and deserve top notch gear on the ice. The new home/away jerseys are from the Flow Brand which are being worn by many top-end programs in Minnesota, but will also last the association for years to come. Next year, all Junior Gold teams will be wearing the new Junior Gold design on the ice.

I'd like to thank the parent volunteers who were instrumental on the EHA Equipment/Apparel committee who helped design, organize and distribute uniforms/socks/apparel for EHA teams.

This year, EHA continued to support several local businesses for fan apparel and travel team uniforms including Camesota, UNRL, and Gemini Athletic.

EHA continued to work with Pure Hockey as the primary provider of equipment, youth uniforms, and CCM/Bauer branded apparel, due to their loyalty points program that allows us to stretch your dollar even further to help our kids in all levels of play.

## EHA Pavilion Update - Robert Braun, Dave Karsnia, Mike Larson, Grant Robbins

Though the project broke ground in September 2021, weather forced us to put the project on hold until the spring of 2022. Phase One was completed in October 2022. The refrigeration system was turned on for the first time November 10<sup>th</sup> as temps allowed and officially opened November 18, 2022. An official grand opening ceremony occurred on January 17, 2023. The rink is expected to be "flooded" in November each year.

EHA gifted \$1.3 million to the City of Eagan to fund Phase One of the project. EHA acquired a \$350,000 loan from a local financial institution in order to make the timely gift. The loan was paid off by EHA in January 2023.

The project is designed to supplement EHA's ice needs at Eagan Civic Arena. Though the refrigerated outdoor ice had cancellations due to heavy snow, rain, or high temperatures; the refrigerated ice allowed EHA to utilize outdoor ice with more reliability throughout the season. This investment is the result of considerable effort by EHA and the City of Eagan and will provide quality ice for future generations. Future phases include a new warming house with a garage and a pavilion covering the entire rink's surface. It is imperative that EHA continues to work with the City of Eagan to complete future phases in the timely manner to increase the reliability of this ice rink for its members.
