### Call to Order: 7:05pm

The approval of the April meeting minutes was tabled until June as there are a few corrections that need to be made.

### President's Report: Mindy

The NLI college signing day had 15 athletes and was a success. The backdrops and table cloths will be kept at the school for future use. The scholarship recipients will be announced on May 23 at the Senior Awards Ceremony. Mindy suggested that we may want to offer the scholarship in the fall when students are applying to colleges and writing essays. This may improve the number of applicants. Mindy would like to keep sponsorship prices the same for the 2023-24 school year. She also stated that paper sports game passes will be provided to Board members and sponsors but all other passes will be electronic. Both cash and electronic tickets for games will be sold next school year.

Joe passed out some merchandise and noted that any team who wins a state championship and had a store with them will get free championship t shirts.
