This form must be signed by every head coach who has notified a school/gym administrator of all the details listed below for all Wisconsin Association of Cheer and Pom Coaches, Inc. ("WACPC") competitive events including, but not limited to the WACPC REGIONAL & STATE CHAMPIONSHIPS for the 2022-2023 competition season (referred to herein as the "Event(s)"). I understand that it is my responsibility to have on my person any and all emergency information for all of my athletes. To my best knowledge, none of my athletes have conditions which would prohibit or restrict their participation. I have obtained permission from my athlete's parents/guardians to allow their child to participate in the WACPC competitive Events. Recognizing my responsibility for knowledge of the rules for cheer/dance, I have viewed the 2022/23 NFHS Rules presentation and agree to comply with the rules as provided in the 2022/23 NFHS Spirit Rules Book. I have informed my athletes, parents/guardians of the inherent and significant risk involved with the sports of cheer and dance. The risks of injury involved in cheer and dance are significant and while participation rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist. It is understood that WACPC has a NO REFUND policy. Each of the undersigned has carefully read all the above statements, and with full understanding of the terms, consents to participation in the Event. My team is aware there are risks of direct or indirect exposure arising out of, contributed to, by, or resulting from an outbreak of any and all communicable disease, including but not limited to, the virus "severe acute respiratory syndrome coronavirus 2 (SARS-coV-2)," which is responsible for Coronavirus Disease (COVID-19) and/or any mutation or variation thereof. My team further understands that there is a possibility that participation in the Event may result in contracting COVID-19. I hereby acknowledge that my team has received education about the signs, symptoms and risks of COVID -19. I also acknowledge my responsibility to report to my WACPC if any member of my team exhibits any signs or symptoms of COVID-19.
