Hopefully your association's leadership shared the date and information about credentialing, and this does not come as a surprise to you. I wanted to send this email over a week ago, but there has been some delays in getting the team contact information.

Credentialing for non-state teams, state-bound JV teams, and remaining girls teams will be held this Sunday, January 25, 2026, at Livonia Marriott, 17100 N Laurel Park Drive in Livonia, MI. Turn to the right when you enter the main doors and we will be in one of the conference rooms.

Last year's checks went better than expected, and this year's district team checks were the smoothest in years. Let's keep that momentum up on Sunday.

Credentialing is mandatory, and we will not chase teams that fail to show like last year. Those who fail to show will be subject to discipline hearings.

2:30PM: 10U B

3:00PM: 10U AA (2015 birthyear teams)

3:30PM: 10U A (2016 birthyear teams)
