

COVID-19 Fall Return to Play Waiver and Conditions



I understand Lamar Soccer Club (the "Club") is following local, state, and federal public health guidelines and the Club is going to be offering training with specific guidelines. I am being offered the opportunity to participate in the Club's fall season (the "Program"). I acknowledge that my participation is voluntary. I knowingly and willingly consent to participating in the Program, and I agree to follow all guidelines and recommendations to prevent the spread of COVID-19. I represent that I have the maturity, understanding, and skill to safely engage in the Program and all other Club activities and to observe all protocols and guidelines for such participation.

I understand that engaging in the Program can be vigorous, physically demanding, and could result in injury. I also understand that the COVID-19 virus has a long incubation period during which carriers of the virus may not show symptoms and may still be highly contagious, and I agree that it is impossible to determine all who may or may not be contagious, given the current limits in virus testing. I further understand that my participation in the Program involves a risk of being exposed to, contracting, or being around players who have COVID-19. I will do my part to follow all protocols, respect the directives, and abide by the requirements to return to play. I represent that I am in good physical condition and do not have any medical, physical, or mental condition that could result in injury or illness for others. I expressly assume the risk of engaging in the Program and other Club activities and hereby release and hold harmless the Club and all parties involved, including the coach, other players and families, the staff of the Club, the facility owners where we train, and local municipalities.

In consideration of being afforded the opportunity to participate in the Program, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I, and my parent or legal guardian if I am a minor, for and on behalf of myself and my heirs, executors, administrators, successors, and assigns, hereby forever release, acquit, and discharge, and agree to indemnify and hold harmless, the Club and its operators, officers, directors, employees, contractors, members, partners, agents, sponsors, vendors, invitees and affiliates (collectively, "Lamar Releasees") from any and all causes of action or actions, suits, losses, liability, damages, claims (including but not limited to, negligence, gross negligence, willful or intentional conduct), personal injury damages, medical or hospital bills, lost wages, property damages, judgments, levies, and executions whether known or unknown, liquidated or unliquidated, fixed or contingent, direct or indirect which the undersigned or his heirs, executors, administrators, successors, and assigns may have, against said Lamar Releasees arising out of my participation in the Program and any other Club activities.

I understand and agree that the foregoing release is binding on myself and my heirs, executors, administrators, successors, and assigns and that the Club will deny my participation in the Program until this release is executed by myself and my parent/legal guardian (if applicable) and all terms are hereby accepted. I understand that, if I am a minor, my parent or legal guardian is required to sign this release.

If my child is a minor, I understand and agree with each matter stated herein, I knowingly and willingly consent to my child's participation in the Program, and I hereby bind myself and my minor child to the terms of this Return to Play Waiver by signing below.

If any provision of this Return to Play Waiver is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement.

I have read, understand, and accept the Return to Play Waiver as outlined above which will be effective from the date signed until rescinded in writing by the agreeing party (adult player or parent of player) or until the club formally announces a return to non-restrictive training.

The following conditions must be met before bringing your player out to training with Lamar Soccer Club until future notice.

The player cannot have had a fever (100.4° or higher), cough, or shortness of breath during the last 7 days without a medical diagnosis. The player's temperature must be taken by an adult within 2 hours before leaving for training. If that temperature is above 99.5 on the day of training, the player cannot come to training.

The player cannot have had any contact with anyone diagnosed with COVID-19 or an unconfirmed but suspected COVID-19 person within 14 days.

The player cannot be experiencing any symptoms related to COVID-19 or be restricted by a healthcare provider.

Players must follow guidelines for entering and exiting fields to reduce contact with other groups.

Participants must wear masks from the car to training and then as exiting the field and maintain social distancing guidelines.

Players must apply self-supplied hand sanitizer upon exiting the vehicle and before entering the fields.

No sharing of drinks or food.

Avoid all unnecessary contact with other players including high fives, hugs, etc.

Only players and team staff (coaches and managers holding an APP) are allowed to come onto the field area during training. We ask parents to remain in the parking lot or further away from the fields during training. We will have separate guidance for games, but masks will likely be required for all spectators at a minimum, and we will require social-distancing and supervision of all siblings to stay with the spectator group.

Parents must be ready to take their child immediately at the end of the training session. Team gatherings before or after games are highly discouraged.

Any player showing any symptoms or possible negative medical conditions may be removed by the coach or any club official immediately and sent home or set apart from the rest of the group until the player can be sent home.

If a player tests positive or is suspected of having COVID-19, that player must notify the coach immediately. The coach will then inform all members of the team who have been in contact with that person during the last 14 days without disclosing the name of the exposed as well as notify their group GM, the club VP, and the club President. The coach or club directors will notify the governing league and STYSA.
