

Important 2025-26 Deadlines and Policies

Offer Accept/Decline Deadlines:

Retention Offer Period: July 1st to July 13th

 Retention offer athletes will need to pay a non-refundable deposit of \$250.00.

Summer Tryouts: Saturday, July 26th & Sunday, July 27th

- 12U-14U Deadline: Friday, August 1st by 7:00pm
- 15U-18U Deadline: Friday, August 1st by 7:00pm

Fall Tryouts:

12U-14U - Saturday, Oct. 4th & Sunday, Oct. 5th

15U-18U - Saturday, Nov. 15th & Sunday, Nov. 16th

- 12U-14U Deadline: Monday, October 7th by 7:00pm
- 15U-18U Deadline: Monday, November 17th by 7:00pm

So you received an offer, now what?

Options when an offer is received:

- 1. ACCEPT This means you are committing to playing for VALLEY VELOCITY for the 2025-26 season.YAY!
- 2. DECLINE This means you are opting not to play for VALLEY VELOCITY for the 2025-26 season.
- 3. HOLD This gives you time to consider all offers before making a decision. A decision of accept/decline will need to be given to all offering clubs by the deadlines listed above. We do ask that you inform clubs of your decision as soon as possible so that other offers can be made to complete teams.

You've Accepted an offer with Valley Velocity!! Now What?

Steps to take after offer acceptance:

- 1. Upgrade or purchase your Badger Region Junior Player Membership for the 2025-26 club season.
- 2. Accept club assignment from Valley Velocity, this will come in the form of an email. Please note: In order for the Badger Region membership to be assigned to Valley Velocity appropriately, we have to send the club assignment email to the same email address used to purchase the Badger Region Membership.
