 - a. Registration fees (notes from May 2023): I added some additional numbers to this shared doc so we can continue the planning conversation. Simply to make ends meet next year, we are looking at a minimum 15% increase, though if we can push closer to 20%, we'll be on more solid ground. When ice rates go up by 30% in one year and other expenses are climbing as well, this is simply the reality of the financial climate and inflation we've seen in recent

- years. The other option is of course to think about what costs to cut, though I doubt there's much appetite for moving away from skills and other optional things that have benefited the program.
- b. **Monthly Financial Summary (for July 2023 meeting):** Our checking account balance as of 07-07-23 is \$76,167.18. Our balance on this date last year was \$120,267.34. Revenues since last meeting include \$9,750 in girls tournament team registration fees; \$1,414 in uniform order payments; and \$685 in swag sales. Significant expenditures from the past month include \$2,990 in girls team August tournament registration; \$300 to Longplex for May event expenses; and \$140 in storage fees. Checks issued for swag purchases (\$2,000) and gamesheet iPads (\$2,363) have yet to clear and will be reflected in next month's numbers.
