3. Willing to agree to comply with the stated & customary terms & conditions for participation. If however he/she observes any unusual significant hazard during his/her presence or participation, he/she will remove him/herself from participation & bring such to the attention of the nearest official immediately, and
4. Herby irrevocably grant to Amarillo Soccer Association and its respective affiliates, subsidiaries, parents entities, licensees, successors and assigns, and those acting with its permission or upon its authority (all of whom are referred to below as "licensed parties") the absolute, perpetual, and unrestricted right & permission to record, copy, reproduce adapt, edit, summarize, copyright, photograph, film, license. Vend, rent, distribute, televise, publish, exhibit, disseminate, perform, & otherwise exploit in any & all markets and media (collectively "use") his/her appearance, name, likeness, voice, documents, participation in the Skip Ferrell 3v3 Memorial Challenge.
