1. Roll Call - L. Doko - Meeting called to order at 6:40PM PDT | 7:30PM MDT by Nathan Kanning

2. Approve June and August Minutes - *Approved*

3. IHSLL Board Election

- *Secretary Lauren Doko voted in unanimously*

4. Extend IHSLL Commitment - Extend the deadline for clubs to join IHSLL for the 2023 spring season from September 19, 2022, to new date such as Nov 1, Dec 1 or Jan 1. *Motion initially proposed by Dave / Jackson Hole; Adam Marfice / Lake City agrees with Nov 1 date. Dave/Jackson Hole makes motion; Commissioner Adam Marfice seconds. Approved unanimously to extend the deadline to Nov 1, 2022.*

5. Vice Commissioner Election - Question: Election or Appointment? Palouse, Snake River and Teton Valley Regional Elections to be completed before Jan 1, 2023. *Motion initially proposed by Adam Marfice / Lake City in email thread Motion proposed by John Lamm / Kimberly and Nathan Kanning/Sandpoint seconds. Each division to decide on a new Divisional Director by election or appointment by 11/1/22 and notifying Commissioner Adam Marfice amarfice@gmail.com and Secretary Lauren Doko IHSLL.Exec.Secretary@gmail.com. Positions will have IHSLL Board voting rights. Divisions to discuss among themselves in October.*

6. Division Adjustment - Move Kimberly from Teton to Snake River proposed by John Lamm / Kimberly. *Motion introduced by Commissioner Adam Marfice and seconded by Dana/Middleton. Unanimously approved by IHSLL membership.*

7. Teton Valley - Request to register team as JV by Rachel Fortier. *Tabled as IHSLL needs to know the firm number of teams within membership first. Additional JV discussion to continue informally after the meeting adjourned for those who are interested.*
