#### Open Forum:

Greg introduced Doug Brown to the board. Ben is associated with Dynamic Fundraising and presented his organization and fundraising opportunities they can provide for the OMGAA. Dynamic Fundraising works with local, regional and national business organizations to provide a collection of money saving opportunities which are compiled and made available through a "card" that would be sold by members and profits would benefit the OMGAA. For this service, Dynamic Fundraising would receive one half of the sales cost, the remainder going directly to OMGAA. An additional "Revenue Sharing" amount would also be returned from Dynamic Fundraising to the OMGAA. The Board agreed to discuss this plan and options under New Business.

### Parks and Recreation Report:

Chris reported MGPR is preparing for summer sports as usual, and that additional fields may be available to the OMGAA if Park and Rec program participation declines. Chris mentioned that BPA (Brooklyn Park) may be closing it's Slow-Pitch softball program and OMGAA might consider offering such a program as an income source.

Training and Development: Jason reported that winter clinics have started and within current Covid Protocols, reached allowable capacity on Sundays. However registrations are down approximately 20%.

Jason has been processing dome rental agreements with several other organizations but acknowledge competition from BPA Dome with rates considerably lower the OMGAA.

Jason has time reserved for Jr. Traveling tryouts and has not received information from the Jr. House program.

HFP/TFP: Holly presented on behalf of HFP and TFP in Cassy's absence. Registration fees will be set at \$230.00 and Traveling fees an additional \$200.00. Tryout fees will be collected at registration as a non-refundable add-on for those registering for TFP.

Jr. H (8-9) "Rookie League": Aric reported an increase of interest in the 8-9 House Program indicating possible rise in both membership and volunteers.

#### Old Business:

Gleason Fields: Greg reported that the City has asked the OMGAA to explore possible bank Guaranteed backing for our obligations of 1,800,000 over the next 20 years. OMGAA had done this for our commitment to the Maple Grove Dome. Scott will discuss our options with our current banking partner.
