The address is listed on the schedule and there is a map attached as well. **Please enter through Door E5.** The map is not great quality, but Door E5 is located on the SE corner of the building. This is on the stadium side of the building closest to Oxbow Creek Drive North. It is the upper level.

The schedule listed on the next page has all the matches for the day. In order to keep the day moving and get everyone out at a decent time, please have your teams ready to go when the previous match is over.

The final page has some basic maps to the buildings and court layout for the high school.

There are some important reminders, competition rules, and general reminders listed below. However, please let me know if you have any questions prior to arriving on Saturday, or check with your Site Directors during the day. Kevin Raap will be the onsite Site Director for the day.

### **IMPORTANT REMINDERS:**

1. Admissions is \$7 for adults and \$5 for students and seniors. Children 5 and under free.
2. No Coaches Meeting. Check-in with Site Director at each school upon arrival.
3. **Tournament play will begin at 9:00a with official warm-ups beginning at 8:45a. Doors open at 8:15a.**
4. ***Warm-up balls will be provided. We ask that teams help keep the same amount of volleyballs in the carts after warm-ups.***
5. ***Champlin Park will provide 1<sup>st</sup> Referees and all table workers. Unfortunately, due to teams playing, Champlin Park will not be able to supply Line Judges. Each team will need to supply a Line Judge for each match.***
6. There will be concessions. We ask that teams support our event and efforts as with other events that teams have attended.  
***NO COOLERS or CROCKPOTS are allowed in the building.***
7. T-shirts will be available to purchase near concessions.

### **COMPETITION RULES:**

1. In the JV portion, play will be best 2-of-3 three sets to 25, no cap unless noted.  
The third set, only if needed, will be played to 15.
2. In the B-squad portion, pool play will be two sets to 25. Bracket play will be best 2-of-3.
2. Warm-ups for each match will be 10 minutes (2-4-4) for the first two rounds, then 8 minutes (4-4).  
Teams should both hit and serve during their 4 minutes.
3. Time between sets is 3 minutes. Timeouts are 1 minute.
6. Ties in JV pool play to be determined using the following criteria without repetition: **1. Head-to-Head, Set %, Point %, Coin flip.**
7. Ties in B-squad pool to be determined using the same criteria as JV pool play. However, if there is a split in sets, point differential will determine the match winner.  
**(Ex: Team A wins set 1 25-20, Team B wins set 2 25-15, Team A wins the match with a +5 point differential.)**

### **GENERAL:**

1. No ball handling is permitted in any location outside of the gym, including hallways and cafeterias.
2. All players must 'nest' in the cafeterias. Each team will have a table to leave their bags at if they wish, or to hang out at during their off time. Please be respectful of other teams and stay off their table.
3. Results will be updated as soon as possible.
4. There will be a trainer on site at CPHS.
5. We will again try to be as paperless as possible. We will have a QR Code that fans can scan to get the updates on their phones, as well as TVs with the results. There will not be any paper postings of results.

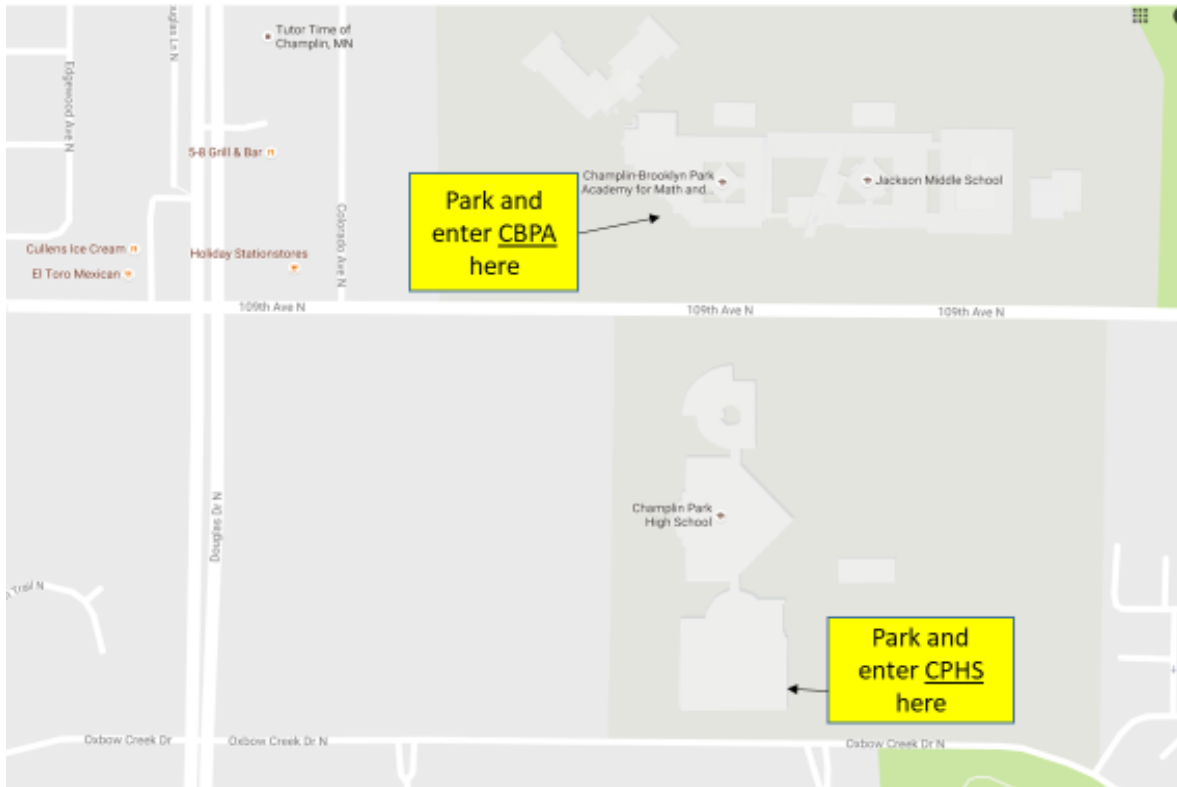
## Bsquad Pool Play and Playoff Schedule
