Procedures and Rules for US/Canadian mixed teams during Spring and Summer:

1. US Players must all be registered with USA Hockey and be on a USA Hockey (1-T) roster.
2. All Canadians must also register with USA Hockey online at USA Hockey.com and be placed on the same USA Hockey (1-T) roster.
3. Each Canadian player's parents will sign a form which indicates that this registration and roster is only valid from April 1 to August 31 of the current year.
4. No resident requirements or transfers documents will be required during this set time period (Spring/Summer).

Procedures for Canadian Teams coming to the US for Tournaments or Games:

1. **This procedure is only for Spring or Summer games.** (Teams coming during the regular season will need to provide an approved Travel permit signed by Hockey Canada or the branch office).
2. Each player must show a current Canadian player card.
3. Teams must present an insurance certificate (general liability) to show they have equal coverage to what USAH provides for members. This policy must be presented for consideration to the USAH Michigan Affiliate Registrar at least 30 days prior to the start of the tournament. Email the certificates to Bob Yohe at michregistrar@gmail.com. Be sure to include the name, date and sanction number of the tournament the team is planning to participate in.

Other Foreign Teams:

1. Any international team coming to Michigan, any time during the calendar year.
The Michigan team or Organization who is hosting needs to start the International Competition form which is obtained from the USAH Michigan Affiliate Registrar.
2. After the form is completed it is forwarded to the USAH Michigan Affiliate Registrar for his/her approval.
3. The form after the Registrars approval is forwarded to USAH International Department.
4. USAH will contact the member federation involved to confirm the team is approved by their federation to participate in a sanctioned event.
5. A copy of the approved International Competition form or confirmation email approving the team's participation will be sent back to the team or organization for their records.

Individual foreign players:

1. International players (non-USA, non-Canadian) **MUST** follow the IIHF Transfer Regulations at all times.
2. All international transfer rules and regulations would apply including resident documentation
3. No International player is to be placed on any **Regular, or Spring or Summer** USA Hockey (1-T) roster without proper documentation and approval from the USAH.



US/Canadian Spring and Summer Mixed Teams

It is the purpose of this agreement that the player and the parents/guardians understand that their son/daughter is participating on a USA Hockey/Michigan Amateur Hockey team for the Spring and Summer season only. They may participate on the Michigan based team from April 1 until August 31 and must be registered with USA Hockey and be on the USA Hockey (1-T) roster.
