- I. Call to order

- II. Welcoming remarks Troy Creurer
  - o No update

- V. Old Business
  - o Outdoor Rink Update Kevin Logan
    - Rob Newvine is not interested in maintaining the outdoor rink.
    - Kevin and Troy to talk to Jim on June 12th for next steps.
    - Board agrees not to spend money on the outdoor rink, money is better spent investing in the Pavilion.
  - o Determine if CMH should add power-skating clinic similar to the goalie clinic next season.
    - Instead of a power skating clinic the board discussed hiring a power skating teacher to attend each team's practices a certain number of sessions during the season. Bryan Parker to add this to the budget sheet for next season.
  - o Send out a request for people to be on the concession coverage list at the start of the season.
    - Discuss next meeting to include during the registration process.
  - Remove concession stand buyout clause from section XV of the CMH Handbook & Policies and create new verbiage around CMH policy for the concession stand.
    - Kevin to email the board the current verbiage in section XV and have the board offer suggestions on new wording.

  - Troy to follow up with John Rosales (House League Coordinator) and see if there's a format he'd prefer.
- o Add coaching & locker room parent payment information to the handbook.
  - Board agrees to pay for the background check for two lockeroom parents.
  - Any non-parent coach all fees will be covered.
  - Kevin to bring policy to the next meeting for review.

  - o All new Steel teams were advised to wait for tryouts before rostering a team to ensure the right skill level exists to create a team.
  - o ACE coordinator for northern section is held tonight. Mandie to send details at a later date.
  - o NYS northern section presidents meeting coming up soon.
