- ➤ Karen Wirkus, former Lion's Gambling Manager passed way last week; helped us get started up at Quinny's and trained and taught Jim Kirkwood the ins/out of the Gambling.
- > Fallen items in the MYHA shed will be cleaned out and slated for controlled destruction.
- Need vote to approve the October 2023 Budget and Lawful Purpose spending.

Ctr. Second by Nate McClanahan. Unanimous. Motion passes.
