- TRR for Beach athlete's discussion
 - 1. Over 325 questions in the question bank
 - 2. Approached Albino P to update the questions for the Beach Rules R program for 2019 delivery and he has agreed
 - 3. Pros:
 - a. Learn the rules
 - b. Builds confidence of the beach athletes
 - 4. Cons:
 - a. Cost of program
 - b. How do we get athletes on here?
 - c. How do we tailor questions for 12U to 23U kids?
 - 5. Look at utilizing the tent and Rules R Athlete Championship with swag and getting the kids on the system
 - 6. Need to work with Guy Bradbury about getting costing for the 2020 season
- Assignor job posting to be sent out by January 2019

ACTION: Kelvin, Suzanne and John to discuss logistics of running a Rules R Championship for the Beach Tour athletes to figure how we get them on the program, what the costs will be for the Referee budget and what is the prizing, length of the contest and what locations we run them at by March 2019.

5. Quality Assurance (Bob Rocque)

- a. Mentorship Program
 - Ryerson University is assisting with theoretical side of the mentorship program at the National level for OTF grant
 - Anyone that hasn't mentored since they were first trained is being removed from the active mentor list

ACTION: Kelvin to distribute list of current Mentors to RRCs by Sept 21st

- Ran a full mentorship program at Beach Nationals. Refs completed a selfreflection survey prior to the event starting. Gives them areas to discuss, aside from just evaluating their skill set.
- Dale Huddleston and Terry Sonoda will be the new Master Learning Facilitators to mentor the mentors
- Will host a mentorship clinic in R3, R4, R5 (and 1 and 2 if needed)
 - 1. Up to 10 candidates per one session.
 - 2. If more interest, will figure out a training plan
- Need to create a profile of responsibilities for the Master Learning Facilitators
- Would like to provide a full mentorship program while at RIM Park for Ontario Championships and utilize the mentors that we use all year





- Mentorship Program Budget concerns OVA budgeted \$15,000 for the program this year → goal is to run 45 mentor tournaments across Ontario by end of the indoor season
 - 1. Covered through the OVA mentor training clinics (\$15,000 budgeted for F19)
- Question about badge level of potential mentors yes, provincial referees could mentor if they are experienced and they can only mentor novice and local lever referees especially in the smaller regions (1, 2, 4)

ACTION:

- Bob Rocque to create an operating budget for training sessions, binders, etc., and send to Alishia by October 14, 2018
- Kelvin to connect with ArbiterSports to find out how the evaluation component of Arbiter works so we can utilize this for mentorship reports and report back to Committee by October 14th, 2018

b. Revenue Neutral Next Steps for National Championship's

- October 1st meeting with Scott Borys and Andrea Baille
- Some push back from VC on this program
- All payment must come out of the VC office
- Need to iron out details and make sure everything is in writing prior to the 2019 National Championship season is in full swing

6. Regional Upgrade Plan/Update (Mark Williamson)

- Review of candidates from F18
- Fourteen names have been put forth for year 1 RUP:
 - R1 2 (potentially), R2=1, R3-5 (potentially), R4-0, R5-5, R6-1 = potential 14 candidates
- Would like to use theory clinic at the OVA office to save on costs
- Feedback from candidates to give them a few prep questions leading up to the exam and this will take place for 2019 delivery
- Want to be more flexible to help people through the exam:
 - o Pass mark is 85%
 - If a person is between an 80%-84%, we ask verbal questions to make sure they understand the rules
 - o If 79% and under, are they out of the program NO. Don't want to turn candidates after first clinic. RUP Clinician has the flexibility to work with those candidates to ensure they understand the rules and they pass the oral interview, that is fine.
 - Moving forward, give them a practice test at the end of the theory clinic and they
 write the final exam at the practical in the spring. If they pass and are refereeing
 at a high level, they can be fast tracked. Need to book a classroom space at RIM
 Park on the 18U weekend for the RUP candidates to write their exam.
- Will book a theory weekend at the OVA office to save costs, potentially last weekend of October – Mark to confirm
- Will look at lining up practical evaluations with U Sport Matches
- Candidates will be working 18UB Premier event on November 17th weekend is practical

 - 274 users since Oct 1, 2017 38% of active refers are users
 - Total # of attempts 21,264 for indoor and 505 attempts for beach
 - Regions 3 and 5 have most users

ACTION: Alishia to figure out % of levels of refs using The Rules R and report back to Committee

b. OTF Project Update

- Reviewing education pathways
- Reviewing connection with long term referee development and long term athlete development
- Reviewing development of mentorship program and educational materials and process for implementation
- Review process to establish online referee education and platform development with a soft launch of fall 2018
- User forum Dec 2018 need 3 people per region to attend to test and provide feedback
- VC due a launch for CCAA and U Sport for January 2019
- Create strategy to engage users from a marketing and educational perspective
- Continue to investigate options to ensure sustainability of the platform

ACTION:

- Alishia to email Guy Bradbury all PRC email addresses for Guy to add them as users to the Referee Academy to play around by Sept 15-2018
- All RRCs to provide 3 names to attend the training session. We want younger, level 1 refs that will see a benefit of the system and provide us with usable feedback by September 15th

9. Handbook - DRAFT

10. Rule Updates/2018-19 Regulations

- a. OUA
- New rule: assistant coaches will be allowed to move freely on the bench, including the warmup zone. Only one assistant coach can stand at a time, with the caveat that the standing assistant coach return to the bench in a timely manner, and not remain in the free zone.
- If school doesn't have paddles, its ok.
- No balls on court when net crew is changing the net heights

ACTION: Andy Cameron to get clarity from OUA Sport Women's regulations regarding # of substitutions for the women's match as it was changed for U Sport Nationals but not in Ontario

b. **OCAA**

- Changed warm up protocol to 5-5-5-5 at coin toss, tell visiting team is warming up first
- Need clarity on where non-hitting teams can be on or off the court
- Using Molten ball
- Allowing 14 players and 6 personnel on the bench

ACTION:

Andy to follow up with OCAA about warm up protocol and if teams can warm up behind the
hitting team and if teams can warm up with volleyballs while the net height is being changed
by the crew

c. OVA

- 14 players on the roster is allowed
- Warm up protocol introduced in F18 is now mandatory
- Teams can list 2 assistant coaches on the scoresheet
- Coaches can now sit anywhere on the bench
- Soft uniform policy for all November tournaments





- Fair Play Clarification due to addition of 14 player roster o 12 different players (or all players listed on the scoresheet) must start either the first or second set.
 - There are no restrictions on who can play in the third set. Any player from the roster may start or be substituted.

ACTION: Andy to get clarity from VC to see if head coach needs to sit in the 1st chair and if a coach yells across the court at the ref, its an automatic yellow card. Was discussed at the NOC meeting but its not included in the rulebook.

- d. U Sport
 - Women use an 8-limited sus rule

11. Updated Local to Regional Clinic Materials

- Local, Provincial & RUP status quo for exams

ACTION: Alishia to save exams in the dropbox folder for the RRCs by September 15, 2018

12. Potential Clinic Dates (Local) - to email to Kelvin

13. Provincial Upgrade Clinics - to email to Kelvin

- Reminder that all PUP potential candidates are to register in NRS by October 15, at which point, Kelvin will forward the list of interested refs to all RRCs for approval
- Once approved, all candidates to register in NRS for the PUP for the year

ACTION: Kelvin to set up PUP interest event in NRS and let RRC's know what the event is active and send out an email blast to all Local refs from 2018 about the PUP process and the even being open in NRS.

ACTIONS:

- All RRC's to forward list of active Clinicians they so we can update the OVA list of Clinicians to what is accurate.
- Mark Wiersma to email RRCs the list of Assignors we have on file ASAP. RRCs to let Mark know what changes they have for F2019 as soon as possible
- RRC's to email Kelvin Regional Kick off meeting

15. Referees Registration/Membership - Late Fees

 Discussion surrounding referees registering late so assignors have difficulty filling early matches, especially for OCAA and CIS





- Do we impose a late fee? \$50? Concerns with how to manage this and turning referees away due to more fees being imposed
- Phased in registration? Level 3 and higher must be registered by Sept 15 to cover Sept pre-season matches for OUA and OCAA and Level 1-2 must be registered by Oct 1
 - Potential option: If you register before XX date, you pay \$xxx, if you register after XX date, you pay the higher fee → early bird option?
 - Can't change for F2019 season, as membership fees are all published and active in NRS (as of Sept 1) → would need to be a change for F2020

ACTION:

- Alishia to ask Finance and Audit committee if we can impose a late fee for F2019, or if it needs be imposed for F2020
- Kelvin to email all refs to remind them to be registered by Sept 30th (as currently states in Ref Handbook online)

16. Assignors Protocol/Guidelines and Accountability

- Number of assignments per official per Region
 - o Out of 130 new refs, 69 referees did not receive one assignment in Arbiter
 - Need to look at ways to ensure all refs are receiving assignments as they can't get experience and improve without assignments
 - Discussion surrounding process after each clinic
 - OVA Referee Coordinator currently emails out the list of new refs to ROC's
 - Would like to add assignors to the distribution list
- International travel (USA events) they need approval from VC
 - Referee to RRC to ORRC to VC to go to USA (approval process)
 - When ref comes back from the States, they fill out the A8 within 30 days after the event and send it to ORRC
 - For cross Region assignments, Ref to email RRC and copies their RRC with traveling dates
 - Discussion surrounding travel to the States to work but didn't fill out proper paperwork – what sanctions are there? Only USAV requires approval to travel.
 Refs are travelling down to AAU events and not getting approval
 - Need to put VC paperwork on OVA website for our of country travel

ACTIONS:

- KELVIN TO UPODATE REF MANUAL WITH PROPER OUT OF REGION AND OUT OF COUNTRY PROCESS. Pull the process from VC website and post on OVA website, along with a link to the form on the VC website
- KELVIN TO SEND OUT A REMINDER EMAIL TO ALL REFS (BLANKET COMMUNICATION) ABOUT TRAVEL OUTSIDE OF THE PROVINCE NEEDS TO BE APPROVED BY THE ORRC AND REMINDER OF THE STEPS TO TAKE AND REMINDER THAT THEY DO NOT HAVE INSURANCE COVERAGE AND SHOULD PURCHASE ADDITIONAL INSURACE TO BE COVERED FOR OUT OF COUNTRY TRAVEL

17. Arbiter Crosschecks

- Please review all fees when assigning adding new slots
- Kelvin to add a note on the homepage of Arbiter to "please let your assignor know if your fees are wrong in Arbiter"





18. Behaviour of coaches and the important of sanctioning

- VC guidelines state the coaches yelling across the court is an automatic yellow card → need to communicate asap to all refs (send out VC guidelines)
- OVA Office continues to receive more formal complaints than ever. However, receiving feedback that mentorship and head officials is having a great impact for our lower level and newer referees
- Need to stress the importance of sanctioning and match management with referees of all badge levels – both indoor and beach
- Look at changing language to according to the rulebook, the coach is getting a card for this, etc. Especially with the younger age groups.

ACTION: Kelvin and Andy to work on monthly communications to start mid-September with pertinent information about registration, upgrade programs, who their RRC's are. Include VC guidelines, OVA What's new and link to YC manual and Ref Handbook for first email distribution

19. OUA Feedback from 2017-2018 season

- a. "New" Warm-Up Protocol Report
 - Any issues? No. Moved down to OCAA level as well for F2019.
- b. Escoresheet Report
 - Any issues? Smooth delivery for inaugural year.

20. Clarifying ORRC Election process for May 2019

- a. Current RRC does not need to step down and they can vote for themselves
- b. If the RRC wins the ORCC election, they appoint a person to take over the region until the end of her term
- c. In the case of a tie, (3 people run, and you get 1 candidate with 3 votes, 2nd candidate with 3 votes and the 3rd candidate gets 1 vote), you drop the person with the 1 vote then revote between the tied 2 candidates. Should only be one re-vote.
- d. What about adding a new position to the committee, to ensure continuity between the ORCC and the past ORCC

MOTION 3: If there is a tie in the vote for the ORRC, the candidate with the lowest number of votes is dropped and a re-vote will take place by the RRC's between the tied candidates.

Bob Rocque & Samara Sevor CARRIED -unanimous

MOTION 4: To update the qualification requirements of the ORRC that they had previous experience on the RRC Committee to be able to run.

Lynn Watkins & Andrew Robb CARRIED - unanimous

ACTION: Kelvin to update Referee Handbook with tie breaking process and that the RRC can vote for themselves and does not need to step down from their position during the voting process. If that person wins the election, the RRC appoints their replacement until the next RRC election.

21. RRC Elections





- Currently every 2 years and all regions at the same time
- Potentially switch this up to all odd Regions are voted on in odd years and all even Regions are voted in in even years and BRC can be voted in on odd years
- Rationale: To have continuity on committee. Theoretically, we could have 7 new
- RRC/BRC's at the table in the current structure
- Could start this for F19 season
- Discussion surrounding terms of ORRCs and RRC terms do we limit or no. NO. keep it open for now. Can continue to discuss at future meetings.
- New RRC will begin August 1st. They would need to be on the spring conference call as the incoming RRC.

MOTION XXX: Any incoming elected RRC or ORCCs are automatically on the Committee and will take over voting rights from outgoing RRC as of the day after the election. There is one vote per region, however, both

Pay by badge level

- Incentive 1: Pay by the level worked. I.e. OUA gets paid the highest, 11U gets paid the least and we reintroduce
- Incentive 2: Pay per badge level I.e. Internationals get paid higher than locals
- Either incentive for OUA, OCAA and OFSAA couldn't change until after 2020, as per 3-year service contract

ACTION: Lynn, Samara, Andrew Robb to work on a draft proposal for committee by December 2018 to discuss two potential options: a) pay rates based on the level worked and b) pay rates based on the referee badge level

m. Direct Deposit

- Jennifer Harkness has been working with ArbiterSports to utilize ArbiterPay.
 Went through demonstrations and speaking to the sales office and went as far as trying to set everything up. ArbiterPay now says they are no longer accepting international clients.
- Jennifer is following up with them now that she is back in the office from maternity leave
- The OVA is going to cover the cost of the deposit fees incurred through a direct deposit system vs the officials budget
