#### **Director Reports**

## General Manager/Ice (Raguckas):

- Weekly schedule is set at this point, awaiting potential response from 10UB coach to confirm availability but honestly have little options to move so hopeful this will work.
- Teams maintain same ice sharing partners to limit exposure
- Note move for 10UA/AA to 6:30pm start on Wednesday from original schedule...to close gap for coach doing 10UAA/12UAA as well as to "share the pain" on 5pm start with house.
- Once decided on options below, motion to vote to approve schedule
- Need to confirm with coaches that only rostered players or student coaches may attend (impacts to contact tracing)
- Game schedule to be shared...currently leaving a 30 minute gap in plan between games. Do we need to do so? Hearing that no other rinks are doing this but will plan until determined otherwise.
  - It is imperative this year that teams maintain this schedule.

- Referees are in short supply, as of last week there were 15 "ready to go" in our area. This was 95 at this same time last year.
- Many are opting out due to not wanting to wear masks or risk exposure
- If you know anyone thinking about getting into it, please encourage them to do so. Clinics are taking place via zoom and you can take any virtual option.
- Requested tournament information prior to making game schedule, only heard from one team.
- 8 teams total, and gaps in schedule do not leave much or really any room to move games around.
- Will encourage teams to practice, will not be able to promise future openings due to above and starting later than usual. Will try to be flexible but will have limited options.
- Need confirmation on start date for Mites, is it still October 5<sup>th</sup>?
  - Start Date: Oct. 13
  - o Mites Skills: Oct. 11 @ 1:00
  - Any idea on timing for jamboree schedule?
- Need to discuss plan for Skills related to scheduling, haven't seen a plan thus haven't scheduled.
  - Potential solutions/proposal:
    - Option 1 Move skills sessions to 1 hour per session on Friday
      - Do two skills sessions per Friday with teams paired with their "practice partners"
      - Each team could have its own locker room or use common area
      - 10UB & 12UB
      - 10UA & 10UAA
      - 12UAA & 14UAA
      - 16U & 18U (would want to confirm attendance as historically has been low)
    - Option 2 Maintain at 80 minutes but cut attendance down (assume would split ice or groups by "practice partners"
      - 10UB, 12UB, 10UA, & 10UAA
      - 12UAA, 14UAA, 16U, & 18U
      - Each team would have its own locker room or use common area
    - Option 3 Eliminate skills until further notice (not desired)
    - APPROVED Option 4
      - No Skills
      - Stick 'n Puck confirmed for 2020-2021 @ 5:30-6:50
      - Every other week
      - Full gear required
      - No coaches required but rostered coaches are allowed to attend
      - Players to show up dressed
      - 1st Session 10/2: 10U
      - 2nd Session 10/9: 12U and above
