**Approval of Minutes:**

**Motion** by Prodgers to accept the 2-26-2021 minutes Seconded by Gresis and passed without dissent

**LEAGUE MATTERS/REPORTS**

1. Approval: Policy Committee. Policy #2 and #3 – Moran Policy Recommendation #2 **Player Assignments by Division Player Evaluation and Assignment Committees (PEAC)**

**Motion by Prodgers to accept the recommendation as presented today. Seconded and passed without dissent.**

**Motion by Prodgers to accept the recommendation as presented.**

**Seconded by Hanafee.** Discussion followed.

Brian Hastings is asking the Board to adopt an amendment that will give the PEAC the recognition and respect that they are the ones to be involved in the process of putting the teams together since they know the players better than the application committee chair.
