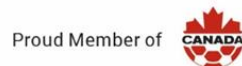

**Subject:** Ontario Soccer Welcomes New Board Member at Annual Meeting

Ontario Soccer has elected a new member to its Board of Directors at the 2022 Annual Meeting of the Members (AMM) on Saturday. This event, which was once again held in-person, marked the organization's 121<sup>th</sup> annual meeting of the members since Ontario Soccer was established in 1901.

**Solomon Amoako** was elected as Independent Director, while **Alice Strachan** and **Matt Williams** were re-elected to their positions as Regional Directors. The Designated Director position remains vacant.

Amoako, the new face being brought into the Ontario Soccer boardroom, brings a depth of knowledge, leadership and soccer experience that will help strategically guide the organization, as soccer returns to normal following the global pandemic.


Amoako has years of experience in strategic planning, sales, business development and corporate governance, and is currently a managing partner at Ribbon Global Inc, a sales and account management firm. As an athlete, Amoako was a successful soccer player, whose accomplishments include Ontario Champion, Canadian National Champion and playing for the U17 Canadian National Team.

The Ontario Soccer Board of Directors also welcomed back two members: Alice Strachan, Regional Director – South, who returns for a third term after being elected in 2018; and Matt Williams, Regional Director – East, who returns for a second term after being elected in 2019.
