**Meeting called to order 8:31 am MDT**

1. Roll Call
2. Confirmation of minutes – May 30, 2015 were approved with a clarification.
3. Treasurer's Report – Lori Stoneburner previously distributed a treasure's report, to the NBOD.
4. President's Report – John Motta reported on USSF Board meetings that have recently occurred.
  - A. Youth soccer match standards have been updated for age groups, size of fields, number of players – implementation for 2017.
  - B. Copa America event for 2016 – this event is under review due to the FIFA corruption scandal that has impacted officials in South America.
  - C. Transfer fees – case out of Washington has gone to FIFA and will be settled at that level
  - D. Women's National Team – Contract for Coach Jill Ellis extended
  - E. FIFA referee list – referees from US were re-evaluated, 2 US men were removed. One male was recommended via performance at National Cups. One female was added from recommendation of John Motta and Angelo Bratsis from performance at National Championship series.
  - F. Washington State Soccer Association – The USSF NBOD accepted the recommendation from the committee that reviewed the case, the current association will remain as the recognized Adult State Association.

- G. National Soccer Hall of Fame – the has been approved and will be in Frisco Texas.
  - H. NASL has petitioned has petitioned USSF to be a Division 1 professional division in competition with MLS. USSF is re-evaluating their required professional standards.
  - I. US Open Cup – USSF has taken over administration of the entire event 6 US Club teams, 5 USSSA teams, 45 USASA teams have registered. Dual ownership teams is an issue that is being discussed. Follow up conference call of committee will take place this next week.
  - J. NPSL Final in Chattanooga – atmosphere was excellent, stadium was completely filled. 18,200 fans attended the match. Rob Lavielle made a **motion** to recognize the Chattanooga and Detroit ownership groups at the AGM in San Antonio. Nick Radu seconded. **Motion passed.**
5. Executive Director Report – Duncan Riddle
- A. 3023 players from US Club Soccer have been registered.
  - B. Aon is no longer offering D&O Insurance. New bids are higher but offer better coverage.
  - C. Midyear Meeting – the Hall of Fame dinner will be Friday night to accommodate people attending or watching the US v Mexico game on Saturday.
  - D. Nevada update – The adult state association will be renamed Nevada Adult Soccer Association. There is a new president and vice president. Darl Rose will be Treasure and Graham Biles is VP of Discipline. The State Association will implement a tournament in mid-November.
  - E. Rhode Island, Indiana, North Carolina, Washington – 4 additional states for pilot program
  - F. Nationwide Insurance sponsorship – will launch after labor day.
6. IT Committee – Arthur Mattson updated the NBOD on the USASA IT Committee. Jen Weston, Kyle Langenwaller, Marley Wilson, Arthur Mattson are on the committee. This committee has a clear set of goals: A) be able to offer a player registration system to State Associations. Looking at buying a white label product that can be edited for USASA needs B) national data base of USASA players.

7. Venue for National Championship Series – discussion on changing the venue from Southern California. Bill Davey made a **motion** to move the National Championship Series/Veterans Cup to the Aurora Sports Complex in Aurora Colorado. Cezar Wasecki seconded. **Motion passed.**
8. West Coast Soccer League USASA Affiliation – Duncan Riddle discussed the affiliation of this league which is made up of college club soccer teams. The registrations would come directly to USASA. Fritz Marth made a **motion** to accept the West Coast Soccer League as a provisional USASA member. Nick Radu seconded. **Motion passed.**
9. USSF Supporters proposal – Rob LaVielle has drafted a proposal for USSF to grant USASA members a level of supporter status, by virtue of USASA paid membership. John Motta and Arthur Mattson will take this proposal forward to Dan Flynn.
10. National Cups & National Championship Series – The NBOD discussed the pros and cons of separating out the Men's National Amateur Cup from the National Championship Series. Arthur Mattson made a **motion** to allocate \$20,000 for staging and \$10,000 for referee expenses, for the National Amateur Cup Finals. Fritz Marth seconded. **Motion passed.**

Men's Open championship will be added to the National Cup Championship Series/Soccer Festival. NBOD would like to define National Championships and National Tournament – revise Cup/championship policies.

Hank Steinbrecher Cup and Michelle Akers Cup – qualifying teams will be contacted for hosting consideration.
11. 2016 Budget – Lori Stoneburner distributed the proposed 2016 budget to the NBOD. Some revisions will be made and the budget will be resent for review.
12. Governance Committee report – the NBOD discussed the submitted proposal from the Governance Committee regarding adding independent board members, size of the board, term length and term limits.
13. Adult Soccer Festival – marketing and naming of individual events was discussed.
14. Referees at the National Championship – Tony Falcone discussed how some of the referees were not up to par, inquired as to how officials are selected for USASA national events.
