#### II. New Business

Appointment of Committees and Resource Groups

**MOTION 1** (**Board Chair**): To approve the Committees and Resource Groups for the 2023-24 season as provided to the Board, details of which are provided in Appendix A which includes Board Liaison appointments.

**Rationale:** The committee task force has reviewed all applications and provided the Chair of the Board with recommended appointments for the 2023-24 membership year.

Appointment of the USA Fencing Treasurer

**MOTION 2 (Board Chair):** That the Board of Directors appoint the current Deputy Treasurer, Emily Bian and USA Fencing Treasurer.

**Rationale:** Ms. Bian has served for approximately 6 months as Deputy Treasurer of USA Fencing, shadowing and learning from our current Treasurer, Mr. Samuel Cheris, as well as playing an active role in the Budget Committee of USA Fencing. Ms. Bian is a qualified CPA, with experience including 4 years with the Big 4 accounting firms as well as over 10 years in corporate control.

**MOTION 3 (Board Chair):** That the Board of Directors appoint the current USA Fencing Treasurer, Samuel Cheris, to Deputy Treasurer

**Rationale:** Mr. Cheris has served on multiple occasions as USA Fencing's Treasurer, his willingness and ability to serve as Deputy Treasurer of USA Fencing allows the incoming

Appointment of USA Fencing Auditors

**MOTION 4 (Board Chair):** That the Board of Directors appoint Briggs Kofford as Auditor for the 2023-24 season by recommendation from the Audit Committee.

**Rationale:** Briggs Kofford have been the Outside Auditor of USA Fencing for over a decade, with a new Treasurer and new members of the Audit Committee, as well as both CEO and Director of Finances in post for just over a year, it is highly recommended to stick with our current audit firm at this time.

Selina Kaing Mike Joo

Rationale: The Special Board Member position exists to fill particular gaps and needs that the Board of Directors has in order to carry out the business of the Board of Directors. Ms. Kaing is an incumbent Special Board Member and has served the Board excellently in her role, notably Chairing the Task Force on Resource Teams and Committees with distinction. Mr. Joo has significant experience in a multitude of roles including Financial Services experience; as well as experience as a Fencing parent, as a Veteran Foil Fencer and as a significant corporate and board experience.

**MOTION 6 (Board Chair):** That the Board of Directors appoint the following Special Board Member for the 2023-24 season put forward for consideration by the Nomination Committee, a biography for Mr. Alperstein is attached as Appendix B.

Donald Alperstein

**Rationale:** Per the USA Fencing Nominating Committee, it is recognized that Mr. Alperstein has served significant time, above that which would be considered termlimited in the current bylaws, on the USA Fencing Board of Directors, and it is further recognized by the Nominating Committee that Mr. Alperstein was not elected by the membership. On the other hand, it is also recognized by the Nominating Committee; that

the Board has had significant turnover in recent years and will benefit from Mr. Alperstein's institutional knowledge and experience which may prove of significant value in the short term to the Board of Directors.

It is noted that if Mr. Alperstein is appointed a further female non-voting member may need to be recommended to be appointed and sought based upon the Gap Analysis of the organization.

# Task Force on Committees and Resource Groups Report to the USA Fencing Board of Directors

August 27, 2023

#### 1. Task Force

The USA Fencing Board of Directors voted to approve the composition of the Task Force on Committees and Resource Groups and appoint the following members of the Board of Directors to the Task Force, with the first person named below to serve as chair:

- Selina Kaing (Chair)
- Donald Alperstein
- Peter Burchard
- Lauryn DeLuca
- Nzingha Prescod

The Task Force expresses its thanks for the assistance from Christina Pachuta, Shannon Jolly, and Nicole Kirk from the National Office who helped review, update, and revise the application form and communications plan. The application window for all applicable committees and resource groups was open from July 25 - Aug 7, 2023 to the general membership and appropriately communicated on USA Fencing's website and standard social media platforms.

# 2. Special Notes for Review Process

Many of the applicants were reapplying to their current committees & resource groups and the Task Force was successful in slotting applicants where possible. Where backgrounds align (e.g. a lawyer who may be a fit for Ethics), the Chair reached out to confirm if the individual would be interested in alternative groups.

- Grievance & Discipline Committee, Coaching Advisory Resource Group, & Data Resource Group: It was determined that due to the recency of the confirmation by the Board of Directors, the current members will continue on their respective committee & resource group appointments; all new applicants will be considered for future openings. The Task Force made this clear to all new applicants in the call for applications and will notify applicants appropriately.
- Divisions Resource Group: It is the recommendation of the Task Force that current members be carried over to next season due to in progress work rolling out new by-law requirements to the divisions. Donald Alperstein as the previous board liaison will continue only in an advisory capacity to complete the work of this resource group.
- Legal Resource Group: Current members are carried over from prior year.
- Task Force Advisory: The Task Force also solicited additional advisors and National
  Office staff with specific areas of expertise to provide input as needed regarding
  Leadership Academy performance, DEIB considerations, specialized areas of

- knowledge such as parafencing, high performance, SafeSport, sports medicine, operations, marketing, finance, etc. Special thanks to Peggy Chin, Ellen Geddes, Glen Hollingsworth, Kate Reisinger, Brad Suchorski, and Beth Mahr.
- Alignment & Discussion Sessions: The Task Force officially met on Aug 18th to review and confirm applicants. Any necessary follow up consultations were held at the Chair's discretion with appropriate Task Force members and advisors previously referenced.

# 3. Applicant Summary

USA Fencing received 99 applications (21% increase from the prior year). The Task Force recognizes the importance of DEIB and the value of diverse representation across our committee and resource groups. The Task Force continued the collection of demographic data this year to help inform our selection process and provide data on future improvements.

- **Gender Identity**: While the majority of applicants were male (52%), there was still a fairly significant number of female applicants (44%).
- **Age Group**: 78%+ of applicants fell into the veteran age categories (41+ and older). **Able-bodied**: There is an opportunity to reach more individuals in the parafencing community as USA Fencing continues to grow the program nationally, but 15% is an improvement from prior year (4%+).
- Ethnicity: 71% of applicants identified White/Caucasian, slightly higher than prior year.
- **Top 3 Committee Choices**: Veterans Committee & Tournament Committee continue to remain the top choices of applicants.

# **Biographies for Suggest Special Board Members.**

#### Selina Kaing – Cupertino, CA.

Selina Kaing leads IT services and procurement related to hardware engineering globally. She joined Google as part of the strategic sourcing team handling the company's multi-billion dollar spend base and has worked extensively in operations and supply chain across a variety of Fortune 500 companies including Disney, Nestlé, Gillette (now part of P&G), and Express (formerly Limited Brands).

The daughter of Cambodian refugees who fled the "killing fields" of the Khmer Rouge, her family was resettled in the U.S. and found eventual success running a small business in California's nascent donut shop industry back in the 1980s. Profoundly influenced by her childhood experiences, Selina is passionate and committed to helping organizations across a variety of sectors scale and grow with an agile and entrepreneurial mindset. She is a startup growth advisor for operations strategy through her involvement with Google for Startups and CapitalG, and brings a wealth of leadership experience to diverse organizations focused on youth, diversity, and community enrichment.

She currently sits on the Board of Trustees for the U.S. Fencing Foundation and Palo Alto Art Center Foundation with prior board appointments at multiple nonprofit organizations and state commissions focused on service and the arts. She has held various committee leadership roles aimed at developing organizational strategy and growing philanthropic giving efforts. She also is an active veteran fencer.

Selina is a frequent guest lecturer and workshop facilitator on topics related to operations strategy, women and leadership, negotiations, and project management. Her thought leadership and research has been presented at academic conferences and university level operations courses. She holds a B.A. from Harvard University and M.B.A. from Oxford University.

#### Michael Joo – New York City, NY.

Mike Joo is Managing Director and COO, Global Corporate & Investment Banking at Bank of America. Mike is responsible for driving strategy and key business initiatives across corporate and investment banking globally.
