Concessions – Anderson –

Discussion on increasing the pay for teen concession workers. Right now, we pay \$8.25 per hour. When we can't get volunteers, we hire teen workers to come in and work. This year we had a difficult time hiring any teen workers. The volunteer fee has been increased for 2022 so hopefully we will have more volunteers and will have to hire fewer teen workers, but we will need have a plan in place if we are still short of volunteers. Fastpitch will be paying field maintenance workers \$15 per hours for

2022 workers. It was suggested to pay concession workers the same. If that is the case, we will need to re-evaluate what we pay the concession coordinator.

Shift times were also discussed and only having set hours on tournament weekends.

It was decided that there are many issues and a committee needs to be formed to bring suggestions to the board.

Stephanie brought up the need for a golf cart for tournament directors and concession coordinator. Next year there will be reserved parking spots for concession coordinators and tournament directors. Stephanie will investigate the cost of used golf carts.

Chet will be the committee leader; participants will be Stephanie, Terry, Nate, Eric. They will meet this month and bring back to the board.
