Hello Montana!!

I hope you all are doing well and that you are able to continue to train without too many covid interruptions. Please read the following information on some changes made by the regional committee, for this year only, in regards to regional qualifying scores. There is also info needed for the state meet.

1. We are trying to get a schedule out for the State meet so if you could please go online to register for state that would be really helpful. If you would just please register all your athletes now, and then you can delete any that do not qualify or will not be attending. We plan on running ALL day Friday-Sunday, and Monday am if deemed necessary by covid restrictions.
2. Please send me any seniors that you may have.
3. Regional Qualifying Scores
 - o All Levels 7-10 will only need to get a 32 at the state meet to qualify for Regionals. There is no percentage of a percentage for level 7/8 just the 32. This is a big change from previous years.
 - o Event specialists for level 7-10 can qualify for regionals by getting an 8.0 or higher on their event (s) at the state meet.
 - o Remember at level 9 you will still need to get a 34 at Regionals as well as the right placement in their age group to go to Westerns.
 - o Rember at level 10 you will still need to get a 35 at Regionals as well as the right placement in their age group to go to Nationals.
4. You should have all received the email about the Destira leotard fundraiser but if you did not please read it below. For each leotard purchased your club will receive \$10.00 back as well as \$10.00 will go to the regional account. Pretty cool!!! If you are interested please contact destira.

General Meet Reminders- things that have been brought up to me over the last month

1. If you have questions about your gymnast score remember there are meet inquiries for that purpose.
2. Please make sure you read very carefully the entry requirements for xcel. As per R&P xcel is not intended to be used for mobility through the WDP.
3. Please make sure you have a record of in house, sanctioned meets, that you used to mobility your gymnast to the next level. We don't want to have a case where a gymnast gets to state and can not compete at the level they are at because there is no mobility score through the previous level.
4. Drop back date- The drop back date has come and gone so you are not able at this point, without petition, to drop back any athletes to their previous level.

I also wanted to say a great big GREAT JOB to all of you who have hosted meets so far!!!! We are so fortunate to be doing meets in this time, many of the other clubs/states in our region are not as fortunate. Thank you all for working so hard as club owners and coaches to be covid/mask mandate compliant!!!!
