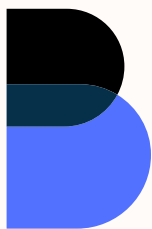

## B) PARENT AND PLAYER CONTRACT AGREEMENT

Congratulations on being accepted to join RONALDO ACADEMY TAMPA/Competitive Program for the **2025-2026 season!** Your skills and hard work have earned you a spot in one of the elite soccer clubs in the area. We focus on making sure that the whole year is enjoyable for our members and their families. As part of the registration process, we want to ensure that you are fully aware and understand the commitments that RONALDO ACADEMY TAMPA organization expects of you and what your obligations and commitments are as a member and/or accepting a position offered.

RONALDO ACADEMY TAMPA methodology stimulates young players to fight for their dreams, while learning soccer at their own speed to keep the development of the player as its primary focus. Success is not measured by wins, but measured by the increased development of your child. Once this is accomplished, winning is inevitable! Please sign and date the last page acknowledging your understanding of the mutual expectations between you, your child, and Ronaldo Academy Tampa.

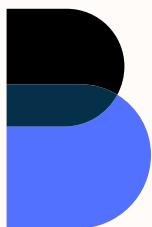
Although we intended to honor the commitment to play with RONALDO ACADEMY TAMPA for the entire seasonal year, we understand that accepting the position offered and completing the registration documents obligates us to pay the full registration fees.

### **The initial letter of intent payment / deposit is non-refundable / referee fee.**

The registration fee covers Training fees, Training Curriculum, FCL/US Club Soccer registration fees, or NPL. However. The registration fee can be paid in full or in installments, as described in the contract. Additionally, fundraising is also a means of payment for the registration fee, in addition to the normal fundraising commitment mentioned in Section B.

It is your obligation to pay the registration fee in full, no exceptions, regardless of whether you later decide to leave Ronaldo Academy Tampa, prior to the end of the seasonal year. Our seasonal year runs from August 11th, 2025 until May 15th, 2026. In addition, a \$200 referee and coach fee will also be paid with the same terms as listed for the registration fee.

### **A.) PARENTS PLEDGE:**

I/we agree to pay the full amount of all fees. If I/we choose to make installments toward fulfilling our financial obligation, we agree to pay the full amount before or by the dates set forth by the organization. The registration fees are in the attached addendum to this contract. The financial obligation can be fund raised or through sponsorship. The installments must be done with automatic payment. The price does NOT INCLUDE other Leagues or Tournaments, uniforms, this price is ONLY for US academy Soccer, One League and insurance.

### **B.) PAY ALL FEES IN A TIMELY MANNER:**

**I/We understand that failure to fulfill our financial obligations to the Ronaldo Academy Tampa will result in the Player's pass being pulled until payment is fulfilled. The player will be placed in "Not in Good Standing" with Ronaldo Academy Tampa and US Club Soccer, which will result in the player's playing privileges being suspended until all the contract obligations are fulfilled. This will also impact the player's ability to register with the Ronaldo Academy Tampa or any other affiliates the next seasonal year. This is mandatory.**

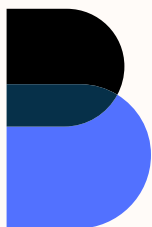
### **C.) UNIFORMS:**

I/We understand that the academy will provide trainers and coaching, opportunities to participate in US Club Soccer, and Tournaments, the player HAS to use the competitive uniforms. The competitive uniform will be ordered after payment.

- Training in the yellow training shirt with the Ronaldo Academy Tampa logo is mandatory. Please ensure compliance with the uniform requirement as an essential component of the athlete identification.

## **D.) PLAYER EVALUATION AND SELECTION:**

I/We understand that the policy for player evaluation and selection will be reasonable and with the best intention, keeping in mind that the best interest of the academy and the team will come first. A player's performance will be evaluated in annual tryouts, training, games, scrimmages, and behavior on and off the soccer field. The Head Coach and Training Staff will consult on matters of player evaluation and selection.

### **Four Areas of Evaluation:**

- Technical Competence (skill in dribbling, passing, shooting, receiving, & heading);
- Tactical Awareness (decision making with & without the ball - reading the game);
- Physical Component (athleticism, speed, quickness, agility, strength & power);
- Psychological Factor (mental toughness, competitiveness, coach ability).

**\*\* Your understanding here is important.**

### **D.1) The Head Coach and Ronaldo Academy Tampa will do his/her best to put together the best team possible:**

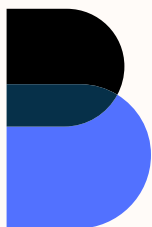
**I/We will not always agree on issues as sensitive as player selection and evaluation, but we must maintain a positive attitude and understand that the Head Coaches and Ronaldo Academy Tampa decisions on these matters are for the best interest of the teams and players development. PLEASE UNDERSTAND: YOUR CHILD IS IN THE COMPETITIVE TEAM BUT THAT DOES NOT MEAN HE WILL PLAY IN ALL COMPETITIVE GAMES. Teams for each game will be decided by the coaches, based on evaluation. Parents are to encourage and accept the decisions made by the Coaches. There will be no parents' inputs in those decisions.**

## **E.) IN THE COMPETITIVE ENVIRONMENT, THERE IS NO GUARANTEE OF MINIMUM PLAYING TIME ON THE FIELD**

**E.1) Players WILL NOT participate in tournaments, sanctioned or unsanctioned, without written permission from Ronaldo Academy Tampa:**

I/We understand abiding by the Ronaldo Academy Tampa policy of not allowing players to guest play with other clubs, or members of other clubs to guest play with Ronaldo Academy Tampa, except with the express written approval of the Ronaldo Academy Tampa. These exceptions will only be granted if all financial obligations have been fulfilled, and will be generally limited to college showcase opportunities that the player would not otherwise be able to participate in, or in unusual circumstances.

**E.2) Ronaldo Academy Tampa encourages students to participate in activities such as futsal, agility, speed, and personal training both within and outside the academy's facilities:**

I/We understand that the academy does not endorse participation in specific soccer training with other team clubs, as this would contravene the principles of mutual respect between the entities involved.

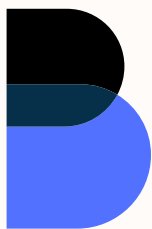
- **The violation of this rule carries a fine of \$180 and notification to the federation, the league, and the other club regarding the breach of this regulation.**

**F.) TEAM EXPENSES:**

In addition to the academy registration fees mentioned above, I/we understand that we will share all team expenses beyond the US CLUB registration fees, to cover items such as specialized training fees, entry fees for additional tournaments, referees fees for scrimmages, and coach's room and travel expenses for out-of-town trips. The team may seek and receive donations or fundraise to offset expenses. All funds collected will be credited to my child's team account and used for team expenses. These funds will remain with the team if the player leaves the academy, and with the association if the team is disbanded.

Parents of players participating in the NPL will contribute to the **ADDITIONAL TEAM EXPENSES**, based on the additional costs incurred for travel expenses, and coach expensive for games outside the academy (\$TBD).

#### **G.) THE PLAYER:**

I/We understand that the commitment to Ronaldo Academy Tampa, signifies the agreement to abide by the policies set forth by the academy and the Team. This commitment is from August 11th, 2025 until May 15th, 2026. At the end of the soccer season, you are free to leave if you feel it's in your child's best interest. From May 15th, students who are financially compliant with Ronaldo Academy Tampa and who wish to go to other clubs will be able to do so.

#### **H.) THE PARENTS:**

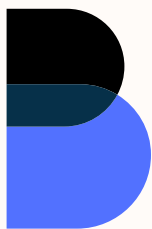
I/We understand that the parental support and involvement are essential to the success of the academy.

Your child is selected, and it is a part of one of our competitive teams, your commitment is necessary and extremely important. If your child is to make a quality commitment to the academy and their Team, you must see to it that they attend all team functions (practices, games, meetings, etc.) without fail.

There will be times when conflicts will not be able to be avoided or other more important family events may occur. If that should be the case, we ask for your timely communication, planning and understanding so that we can minimize the conflicts. It is the Head Coach's responsibility to provide a schedule in a timely manner to allow time for your family planning. When your child has an unavoidable conflict, we expect timely communication (minimum 48 hours prior to the event) in order to make all the necessary adjustments. Final decisions on scheduling will be made by the Head Coach, after careful consideration of your needs, the needs of the team and those of Ronaldo Academy Tampa.

## I.) BREACH OF CONTRACT:

I/We understand that if the player wish to be released (other than for season ending injury or a move out of state), transfer to another affiliation, or quit (stops coming to practicing and games) the team prior to the end of the seasonal year, the player/parents will be required to pay a **\$800 exit fee to Ronaldo Academy Tampa.**

In addition to fulfilling all financial obligations noted above before the change of status is processed (this includes all remaining monthly payments and tournament fees). This exit fee can be waived in certain circumstance, such as if someone is moving out of the area, but that is up to the discretion of Ronaldo Academy Tampa staff and should be discussed prior to the exit from the Academy.

Breach of Contract also covers any parent or player who breaks the rules and guidelines set by this contract. If this happens, the Ronaldo Academy Tampa has the right to suspend or remove any parent or player from its organization.

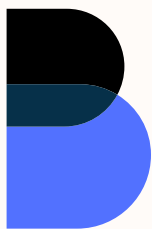
- **Under no circumstances are games allowed to be cancelled. If the team fails to attend a scheduled game, a fine of \$1.550 will be imposed.**
- **The fine will be divided among all athletes and paid to FCL, US Club Soccer or NPL, depending on the league affiliation.**
- **Should an athlete or parent violate the internal rules and policies, the parents will be responsible for covering the fine of \$1.550.**

## J.) BEFORE, DURING, AND AFTER THE GAMES:

I/We understand that the players will be participating in practices, league games, tournaments, state and regional cup games. Upon the designated arrival time, players are expected to concentrate on the sport, arrive on time with the required equipment (cleats, ball, proper uniforms, shin guards, water, bag, warm-ups, etc.) Without exceptions, players are expected to focus on their team and game until they are released by their coach.

**I/We understand that parents are not allowed to approach the coach's side line before, during, or after the games without the coach's request. Only the players and coaches are allowed to be in the bench area during those times. This rule is strongly enforced. Parents need to stay on the parent side line until the Head Coach dismisses the team. Failure to abide by this rule may result in suspension of the parent, player or both. Additionally, Ronaldo Academy Tampa reserves the right to remove any parent or player from the academy that does not abide by these rules.**

### **J.1) 48 hours "No Contact Rule"**

I/We understand that parents must follow the correct protocol after a match. If a parent is unhappy with their child's coach decision and feels that a meeting is needed with the coach, that must be submitted through the Ronaldo Academy Tampa. Please do not contact coaches after games, via e-mail, or phone, and always wait 48 hours after the match to do a requirement.

### **ZERO TOLERANCE:**

**\*\* Ronaldo Academy Tampa depends on the discipline of not only our athletes but also of parents.**

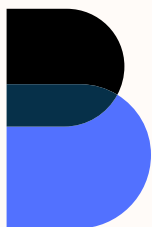
**Ronaldo Academy Tampa does not tolerate the presence of alcoholic beverages within the premises of the field, whether during training sessions or official matches.**

Ronaldo Academy Tampa does not tolerate parents who, may have differences with the team coaches, that gossip to other parents about their own views, creating a forum or faction. That only creates problems. Speak to the coach or to the professionals at Ronaldo Academy Tampa to resolve the matter in question. Such behavior or repeated offenses may lead to immediate termination of your child's Membership with the academy.

For this reason, Ronaldo Academy Tampa is able to utilize its discretion at any point in the season to terminate a contract and membership of a player who they feel does not represent the club well or is causing internal/external issues, this includes the actions of the player's family (ex: parents, adoptive parents, siblings, etc).

### **K.) DISCIPLINARY ACTIONS:**

**\*\* Parent/Player, please read carefully**

Ronaldo Academy Tampa is committed to clearly defining the expectations between the Academy, its coaches, and the players. This agreement outlines the responsibilities of each party, ensuring a shared understanding of what is required from the player and what support will be provided by the academy, the team, and the coaching staff. In case of any uncertainty regarding these expectations, it is the parent/player's responsibility to seek clarification from the Head Coach or Ronaldo Academy Tampa. The academy upholds high standards for both itself and its players, fostering a positive, constructive, and supportive environment. While challenges may arise, the academy remains dedicated to collaborating with players to identify and resolve any issues that may occur.

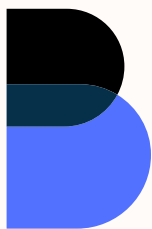
However, if a member remains uncooperative despite the Academy's best efforts to provide support and resolution, disciplinary action may become necessary. The Academy expects players and parents to uphold their commitments, and decisions regarding participation should be made with careful thought and consideration.

Once a commitment has been made, full participation and support throughout the entire soccer season are expected. In return, the academy will honor its commitment to the player, providing the necessary guidance, resources, and support for development.

No player will be cut from a team during the soccer season unless it's for disciplinary reasons, which includes the actions of both the player and associated family (parents, siblings, etc).

Decisions made regarding temporary suspension or complete expulsion from the academy will be made by the Head Coach and Ronaldo Academy Tampa. Decisions made by Ronaldo Academy Tampa are final and are irreversible.

- By signing this contract, parents and players understand that they can be removed from the Academy at any time if the Head Coach and staff feel they are not abiding by Ronaldo Academy Tampa rules and guidelines.
- As a member of Ronaldo Academy Tampa, you are responsible for your own performance and conduct. Honesty, respect for everyone without exceptions: every member of the academy, opposing team members and referees.
- Communication and reliability will be expected at all times.
- Players are encouraged to maintain passing grade point average while registered with Ronaldo Academy Tampa.
- Coaches will honor parents' decision to have a player sit out a game for disciplinary action from home.
- Players under disciplinary action are still obligated to be at the games to support their teammates.

I/We have received and read Parent and Player Contract Agreement - K.) DISCIPLINARY ACTIONS, and we understand and agree to abide by the requirements.

#### **L.) RONALDO ACADEMY TAMPA COMPETITIVE UNIFORMS:**

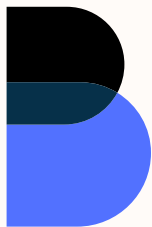
I/We understand that the uniforms can not be changed nor have anything added to them by members, that is for the jerseys, shorts, and socks. Unless a written authorization by Ronaldo Academy Tampa is given, the uniforms are to remain as they were delivered to the players. **Ronaldo Academy logo cannot be utilized, copied or changed in any way, it is an infringement of the law.**

#### **M.) CLUB NAME AND LOCATION:**

I/We understand that Ronaldo Academy Tampa is an expanding soccer club that aims to bring the gift of soccer to youth in the Tampa Bay area.

For this reason, Ronaldo Academy Tampa reserves the right to make any organizational changes that are seen as necessary for the betterment of the club at any point in the season. This includes changing the name of the club and the location of the complexes/soccer fields.

I/We understand that players and parents should conduct themselves in accordance with Ronaldo Academy Tampa, US Club Soccer, FCL League, NPL and FIFA rules at all times, or they will be subject to disciplinary action.

#### **N.) OUT-OF-GAME INJURIES:**

I/We understand that oftentimes the Ronaldo Academy Tampa will train, practice, or play games at locations that also have playgrounds or other areas for children to play. Ronaldo Academy Tampa (and the owners/administrators of the location) are not liable for any injury that occurs on the property outside of gameplay and practice. This applies to both the players/athletes and any children or adult accompanying those players.

#### **O.) ACCOMPANYING ANIMALS AND PETS:**

I/We understand that there will be no animals or pets allowed at any Ronaldo Academy Tampa games, practices, or trainings except registered service animals.

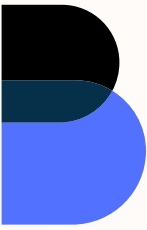
#### **P.) PAYMENTS:**

I acknowledge that this is a security measure adopted by the academy to cover any late payments or other fees that may arise.

\*\* Payments for the competitive program are mandatory on the 2nd of each month. For exceptional registrations made after August 2nd (Option 5), the payment schedule will still be set for the 2nd of each month, unless the registration occurs within 7 days before the end of the month.

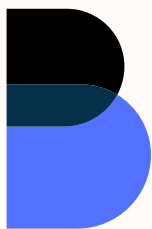
**INFORMED CONSENT:**

## POLICIES AND PROCEDURES

Policies and Procedures to answer some questions you may have throughout the season.

### **Contract Agreement**

Parents must read and sign Ronaldo Academy Tampa Code of Conduct and US Club Soccer Code of Ethics each year before entering into the season.

### **Uniforms**

Uniform Package includes: 2 Game Jerseys, 2 Game Shorts, 2 sets of socks, and 1 shoes bag. **The training T-shirt is free only for those who registered until July 5th, for those who registered after, the cost of the training T-shirt will be \$20.** Extra uniform pieces may be purchased separately through the registration process on our website. Uniforms will not be ordered until paid in full.

### **Organization Fundraising**

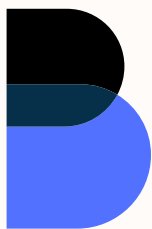
Every Player is encouraged to participate in the academy's annual fundraiser. Ronaldo Academy Tampa will coordinate various ways for the fundraiser: raffle, bingo, etc.

### **Team Fundraising**

Fundraisers, sponsorships must be approved by the Ronaldo Academy Tampa 10 days prior to the fundraising event. All funds collected will be credited to the Team/Player account. These funds will remain with the Team. Team Funds remain with the Team as the Team moves up in age group. Team Funds remain with the Organization should the team disband. A Parent must accompany their Player if the location of the fundraiser is not at the field. **Ronaldo Academy Tampa has a NO REFUND POLICY.**

### **Player Evaluations**

Players will be evaluated in annual tryouts, training, league games, scrimmages, and behavior. The Head Coach/Trainer, Training Staff on matters of player evaluation.

- Players will be evaluated in the following four areas:
- Technical Competence (*dribbling, passing, shooting, receiving, heading*)
- Tactical Awareness (*decision-making, reading/playing the game*)
- Physical Component (*athleticism, speed, quickness, agility, strength, and power*)
- Psychological Factor (*mental toughness, competitiveness, coach/leading ability*)

### **Absences/Tardiness**

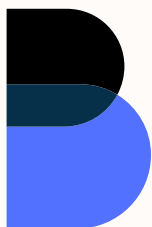
- It is the Player's responsibility to the team to be on time for practices, scrimmages, league games, and tournament games. Some practices will be at different locations from our academy. The practices can change locations.
- Absences must be reported to the Coach/Trainer on time, so that arrangements can be made for the games and the team.
- Repeated absences and tardiness will not be tolerated.
- **Absence from training does not absolve the parent/player from paying seasonal payments.**

### **Sideline Behavior**

- **PARENTS ARE NOT PERMITTED ON THE SIDELINE DURING COMPETITIVE TRAINING SESSIONS. THEY MUST REMAIN IN DESIGNATED AREAS OR INSIDE THEIR CARS.**
- Parents will not be allowed to “coach” from the Parent sidelines. This is very distracting to the players, harmful to team play, and it does not represent the philosophy of Ronaldo Academy Tampa.
- Parents MUST comply with the US Club Soccer Code of Ethics.
- Parents failing to comply with these sideline rules may result in removal from the game and future games. Ronaldo Academy Tampa also reserves the right to remove any parent or player from the club.

### **No Contact Rule**

*There is a standard 48 Hour "No Contact Rule" in place after games, regarding contact with coaches or assistants in reference to the game. This includes "face to face", email, and telephone conversations.*

In a case of an emergent situation, there is a protocol to be followed, in order to request a meeting with the Coaches and/or assistants within the 48 hours *No Contact Rule* period. Report to your Team Manager and she/he will initiate the process and make sure everything has been submitted through Ronaldo Academy Tampa. This process will take no more than 24 Hours.

### **Private Training**

Ronaldo Academy Tampa offers private training sessions with the coach of your preference. Private Individual/Small Group Training sessions will be available at an additional cost. To find out more about private classes, please e-mail us at [contact@r9tampa.com](mailto:contact@r9tampa.com).

### **Guest Players**

Players will not participate as a guest player outside of Ronaldo Academy Tampa for games, tournaments, etc. unless they have written approval from their Coach/Trainer and Ronaldo Academy Tampa, documented by the US Club Form.

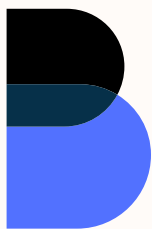
### **Exit/Transfer Fees**

Should a Player wish to be Released/Transferred to a different Organization within the season year, there will be a mandatory **Exit Fee of \$800.00** applied, must be paid in **Cash or Cashier's Check** to Ronaldo Academy Tampa. Additionally, the player is obligated to meet any other financial commitments, including the remaining monthly payments and tournament fees.

- The Exit Fee will not apply if the Player has a season ending due to injury/illness (doctor's prescription needed) or moves out of state (new residency address needed).

### **Player Image**

You, the legal guardian of the athlete, authorize the use of the athlete's image in any and all material including video images, photos, sounds, and documents by the RONALDO ACADEMY TAMPA team, with corporate qualification set forth in the TERM OF CONTRACTING (attachment I), spontaneously and free of charge.

### **Late Payments**

If, for any reason, payments are not made within 30 days of the payment due date, the academy will take the following actions:

- 31 Days Late: Notify the Director of Coaching, Coach, and Team Manager of the balance due and that the member is not in good standing. The player will receive a warning that if payment is not received within 30 days, they may be suspended from training and games.
- 61 Days Late: The director of Coaching will take appropriate sanctions until such time that the players' account is returned to good standing.

**\*\* US\$10.00 (ten dollars) per month Late Fee if the monthly statement is not paid by the 7th day of the month. NO exception. \*\***

The Competitive Program includes practices twice a week, registration of US Club Soccer, Registration and fee of FCL League or NPL League, and insurance. We will also have physical practice to improve the physical conditioning of the Athlete in our home field, included in the price of the season. Players can take extra classes with other Ronaldo Academy Tampa teams for a fee of \$25 per class. Other Leagues and Tournaments that Ronaldo Academy participates are **NOT INCLUDED** in the price, but participation in Tournaments is **MANDATORY**. We anticipate all teams to participate in at least 3 tournaments, please plan on spending \$300 or more extra on tournament fees.

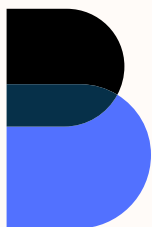
### **School Calendar**

National Holidays are observed just like at any school, we have Winter Break, Spring Break, and School Break, these days off are included in the payment. Other holidays can be rescheduled, depending on the situation, and it will be decided by the Academy. If the training is cancelled due to rain and thunderstorms, the training is going to be rescheduled based on the availability of the coach and the field, **it is not mandatory to have it rescheduled.**

### **Tournaments and Games**

Each team (parents and players) is responsible for getting their tent, chairs, vests and water, and Gatorade for the trainings and games. When the game is a Home Game, we need to provide a bench for the opposing team and the adversary for us when it is at their home.

- Players are also responsible for bringing their ball to the training sessions, with the recommendations regarding measurements and sizes provided by the academy (from 2006 to 2012 ball size "5"; from 2013 to 2018 ball size "4").

Each team is going to elect a parent to be the **Team Manager** and be responsible for the Team activities.

### **Team Goals**

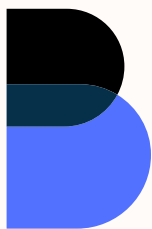
- Not just develop better players, but also develop better people.

- Help players grow as individuals and in their love for the game.

### **Team Rules and Code of Conduct**

Practice times may change due to emergencies or scheduling conflicts. Players must arrive at least 5 minutes early; practice starts promptly. If late or absent, parents must notify the coach at least 20 minutes in advance. Late players will complete extra fitness work. Missing 2 practices in a row without a valid excuse results in ineligibility for the next game. On game days, all players must arrive 1 hour before kickoff for proper warm-up.

### **Practice Behavior**

- Players must bring their water into the field during practice. The players are not allowed to leave the field to go drink water, sit on the benches, go to the car, etc. We have a short amount of time to work so water breaks are meant to be brief.
- Players are to be given a grace period of three (3) strikes for behavior.
- If a player receives three strikes, they must sit on the sideline for the rest of practice.
- If a player sits out for 2 consecutive practices due to strikes, they will not play the following game.

### **Violations for a strike may include but are not limited to:**

- Being late without coach having prior knowledge.
- Back-talking to coach.
- Not wanting to cooperate/disrupt the practice.
- Excessive talking while coach is giving instructions.
- Fighting/Arguing with coach or teammates.

### **Unsportsmanlike Conduct**

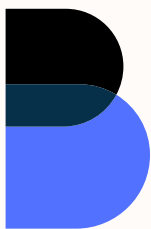
- Players **MUST** wear shin guards and cleats to every practice along with the Ronaldo Academy practice uniform
- Parents cannot "sideline coach" during practice as it distracts the players and takes attention away from coach. Parents are welcome to advise players post practice.
- Parents cannot disrupt coach during practice. If parents have a question, comment, concern they must address it before or after practice
  - **REMEMBER! Parents are not permitted within the training field area. They are required to remain in the designated parent zones or wait within their vehicles.**

### **Game Conduct**

- All Players must be at the field ONE (1) HOUR before the start of the game for a sufficient warm-up.

- Players MUST bring BOTH sets of uniforms to all of our games, just in case there is a conflict with the opposing team.
- Players must wear shin guards and cleats to every game, or they will not be allowed to play.
- Players must bring their water with them and leave it on the bench to avoid players having to run across the field and leave the team for water.
- Parents must refrain from yelling, cussing, or threatening the referees during the match. They are terrible, but only the team will suffer.
- Parents cannot “sideline coach” during a game. The players are already nervous enough; too many instructions will confuse them.
- Parents must wait 48 hours after a game to speak to the coach, per Ronaldo Academy Contract.
- Players will not fight with the opposing team or teammates during the game. If so, the player will sit out the following game as well.

### **Team Events**

After every game is an opportunity for the players to come together and bond. It is important that you, the parents, support this rapport. Parents will alternate every game to bring snacks for the players post game (Juice boxes, chocolate milk, fruit, chips, etc.), we want the players to have a good experience after the game, regardless of how the game goes.

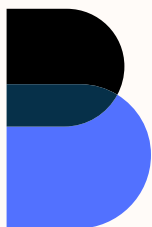

## **UNIFORM**

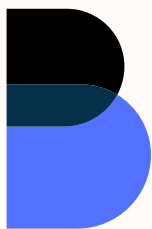
