## Minutes

A motion was made to approve the November 13, 2018 proposed minutes by John Lord and seconded by Blake Sabers. Motion carried.

## **Committee Reports**

**Treasurers/Finance Report:** Sarah sent out the financial reports for all to review. Due to the city lease being due, a request was made by Sarah to transfer \$20,000 from Capital Outlay to Savings. The funds will be transferred back once we have revenue come in to cover the \$20,000. Motion carried.

A motion was made to approve by Al Huls and seconded by Steve Laufman. Motion carried.

**Executive Committee Report:** The Executive Committee did not meet.

**Programs Committee Report:** The Programs Committee met on December 4, 2018. See Programs Minutes for specific information. Four items were discussed at full board:

- 1. Coaches Meeting-A motion was made by Steve, second by Jaycent to approve MSHA purchasing pizza for an in-house coaches meeting once per month, or one sit down meal at a local restaurant per year (no alcohol). Motion Carried.
- 2. PCA Shortage-A motion was made by Michelle, second by Al to approve a 50/50 drawing at all home league level games to cover the shortage of donated funds for the PCA training. Programs will coordinate, and Michelle will obtain the raffle permit from the city. Motion carried.
- 3. Poor youth game attendance-In an effort to increase youth attendance at games, and possibly recruit new players, a motion was made by Michelle, and second by John to approve free admission for Mitchell area students, to include MTI and DWU; with a student ID. Motion carried.
- 4. MSHA Anniversary Event-December  $30^{\text{th}}$  from 4:30-6:30 MSHA will have a celly-bration event at the rink .

**Buildings Committee Report:** Roger reported the Olympias are running fine after both have been sent in for major repairs. He will be working on divider boards and net maintenance.

#### **Old Business**

MSHA Mission Statement and handbook Lana has drafted a Mission Statement for the MSHA. Jonathon Guenther is working on updating the handbook.

A motion was made to approve by Al Huls and seconded by Michelle Loecker. Motion carried.

<u>Avera Employees Pink the Rink Event</u> All Avera employees will receive free admission to the Pink the Rink Event.

A motion was made to approve by Jaycent Reimnitz and seconded by John Lord. Motion carried.

<u>Former player helping coach at Bantams over Christmas Break</u> A request was made to allow a former player assist the Bantams over Christmas break. Due to a sufficient coaching staff, and the former player not having modules completed/USA Hockey registration, a motion was made to deny the request by Michelle Loecker and seconded by Al Huls. Motion carried.

## **Discussion**

Middle School use of MAC Parking Lot Due to the congestion of the MSHA parking lot, a request will be made for the Mitchell Middle School to use the main school entrance and not the NE doors. At times there are buses and several parents waiting in line for MMS students in the MSHA parking lot, which restricts hockey players/parents from accessing parking spots. Brian will talk with Dan and the School Bus Company. However, when we built the second sheet of ice, it was agreed upon that MMS would be allowed to use the rear access. At the time it did not seem it would be a problem, but it has become a traffic safety issue.

#### Student Game Attendance -

some ideas to get more kids at the games – We have a younger adult tweeting game schedules, spirit wear times and score updates and they had a few ideas/suggestions: have Ugly Sweaters for the Friday December 28<sup>th</sup> home game and then possibly free admission with a canned good (need to get board approval) and showing the ticket taker that they are following the Marlins on Twitter. (we will also check with them on doing the same on Instagram/snapchat). We'd like to continue the dress up ideas on future home games to increase attendance of the kids.

## Player (stars) of the game

#### Ideas:

- Hockey puck toss for player of the game (3 stars) they won't just chuck it over the glass, they will be right at the boards to give the puck to a person in the stands (or light toss over the glass) we will start this at the first GV game this weekend. Lori will contact Jessica to make her aware and will have the announcer let the crowd now so they stick around at the end of the game. We anticipate announcing the players immediately after the game so they will not leave the ice but will sign the puck and hand it out to someone in the crowd.
- Player cards that the kids can collect and have their players sign have a few jr/sr players available to sign after home games Sonya will check on player card pricing from Photography Unlimited. If it is too expensive, we can also use 8x10 color copies for each player and Lori would take pictures and do the background much like the player of the game pics. It would also be fun if we had a prize (candy bar) for any kid that collected all the player cards/pics by the end of the season as they would need to attend the majority of the home games to get them all.
- Dividers up to allow the kids to high-five/greet the players as they are taking the ice between the end of the jv game and when the varsity players take the ice for warmups we'd like to get the younger kids excited to see their players on the game. We could set the dividers up over by locker 6 so that that kids can still greet the players and be safe from skates, sticks, etc. We would then have to make sure all kids returned to the other side of the rink.
