- Optional: Bring copies of the wrestlers' USA cards to the Dec. 4 optional turn-in at Stebbins at 11-1.
- Mandatory: If 1 and 2 skipped, must bring copy of wrestlers' USA cards to team's first meet.
- For wrestlers added after team's first meet, send copy of wrestlers' USA cards to Amanda Burr with this MVKWA order form.

USA Card Notes:

- If USA cards are brought to the Nov. 21 meeting or Dec. 4 forms turn-in, the MVKWA Weigh-In Cards from this MVKWA Order Form can be stamped as having USA cards then. Otherwise the MVKWA Weigh-In Card is stamped at the weigh-ins check at the team's first meet.
- A wrestler's MVKWA Weigh-In Card must be certified as having a USA Card (stamped on MVKWA Weigh-In Card) in order for the wrestle to wrestle in an MVKWA meet. The card must be checked at pairings.
