

## **IRONMAN® SWITZERLAND THUN SWEEPSTAKES**

### **Official Rules**

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.**

IRONMAN® IS A REGISTERED TRADEMARKS OF WORLD TRIATHLON CORPORATION.

**1. Eligibility:** To be eligible to enter the “IRONMAN® SWITZERLAND THUN SWEEPSTAKES” (the “Drawing”), you must be:

- (1) an individual at least 18 years old at the time of entry;
- (2) a resident of Austria, the Czech Republic, Estonia, Finland, France, Germany, the Netherlands, Norway, Spain, Ireland, United Kingdom, or Switzerland;
- (3) not an employee, officer, director, or agent of an IRONMAN Group Company, or any of its parents, affiliated companies, subsidiaries, licensees, suppliers, printers, or advertising or drawing/contest agencies, and not otherwise involved with or associated with the Drawing;
- (4) not an employee, officer, or director of any company or organization associated with the Drawing;
- (5) not a shareholder of any company referenced in item (3) or (4) above (but only if such company is not a publicly traded company); and
- (6) not an immediate family member (as defined below) or a household member (as defined below) of any individual referenced in item (3), (4), or (5) above.
- (7) not a professional triathlete; and
- (8) not planning to become a professional triathlete prior to September 2022.

“Immediate family members” means parents, step-parents, children, step-children, siblings, half-siblings, spouses, and domestic partners. “Household members” means people who have the same residence at least three (3) months during the past twelve (12) months. The Drawing is subject to all applicable federal, state, and local laws and regulations. The Drawing is void where prohibited by law.

This Drawing is accessible online through Sponsor’s websites and targeted to the inhabitants of the countries listed in clause (2) above. IRONMAN Switzerland AG may not be able to prevent inhabitants of other countries to register for this Drawing. IRONMAN Switzerland AG therefore reserves the right to, in its sole discretion, disqualify any participant or reject any entry of a person having his/her domicile or habitual residence not in one of the countries mentioned in this clause (2) above.

**2. Sponsor & Administrator:** IRONMAN Switzerland AG (“Sponsor”) located at Ringstrasse 20, 8600 Dübendorf, Switzerland.

**3. Agreement to Official Rules:** The participation in this Drawing is subject to the acceptance of the terms and conditions in this document (“Official Rules”). By participating in the Drawing, entrant

represents and warrants that he/she has read and understood, and fully and unconditionally agrees to and accepts, these Official Rules and that the decisions of the Sponsor are final and binding in all matters related to the Drawing. Winning any prize is contingent upon fulfilling all requirements set forth herein.

**4. Entry Periods:** The Drawing entry period begins at **12:00:00 A.M. Central European Time (“CET”)** on **March 28, 2022** and ends at **11:59:59 P.M. CET** on **April 10, 2022** (the “Entry Period”). Sponsor’s computer is the official timekeeping device for this Drawing.

**5. How to Enter:** NO PURCHASE IS REQUIRED TO ENTER OR WIN THE DRAWING. LIMIT ONE ENTRY PER PARTICIPANT. Individuals may enter the Drawing during the Entry Period in one of two ways:

(a) First Method of Entry:

By registering, during the Entry Period, for the IRONMAN® Switzerland that is currently scheduled to occur on or around July 10, 2022, in Thun, Switzerland. *(Please note: Anyone who, on or before March 27, 2022, registered for the IRONMAN® Switzerland event, will be automatically entered into the Drawing.)*

(b) Second Method of Entry: By mailing a post card (measuring 3.5” x 5”) requesting an entry in the Drawing and a legible statement of the entrant’s:

- (ii) E-mail address;
- (iii) Telephone number;

- (v) Address of primary residence.

Each such post card received will entitle the entrant, if otherwise eligible under these Official Rules, to one (1) entry in the Drawing. (The prize winner may also be required to provide other information needed or useful in order to facilitate sending and receipt of the prize.)

Each entry, regardless of which entry method is used, has an equal chance of winning as any other entry.

**6. Drawing:** On April 12, 2022, Sponsor will conduct one (1) random drawing from all eligible entries. The first eligible entry drawn will be the Prize winner for the Drawing, subject to the respective entrant

complying with and fulfilling all requirements of these Official Rules. Each entry has an equal chance of winning as any other entry.

The potential winner will be announced on the IRONMAN® Switzerland Instagram and Facebook pages. The potential winner will also be notified by email at the email address provided by such entrant. To claim his/her prize, the potential winner must: (a) respond as directed within ten (10) days after the first notification attempt (the entrant is responsible for ensuring that his/her email address is enabled); and (b) return to the Sponsor, by the date and manner specified, the applicable affidavits and releases as may be required by the Sponsor. If any potential winner cannot be reached within ten (10) days after the first notification attempt, or fails to comply with any of these Official Rules, or if the Sponsor determines that the winner is ineligible or disqualified, an alternate winner will be selected by random drawing from the remaining eligible entries.

**9. General Conditions:** In the event that the operation, security, or administration of the Drawing is impaired in any way for any reason, including, but, not limited to, fraud, virus or other technical problem, the Sponsor may, in its sole discretion, either: (1) suspend or modify the Drawing to address the impairment and resume the Drawing in a manner that best conforms to the spirit of these Official Rules; and/or (2) award the prize(s) in a random drawing from among all eligible entries that have registered up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Drawing or to be acting in violation of these Official Rules, or in an improper manner. Any attempt by any person to undermine the legitimate operation of the Drawing may be a violation of criminal and civil law, and, if such an attempt is made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
