50% of SBAA's budget comes from unpaid volunteer fees. How can we change this? Where should the money come from. What to do with the concessions. What are the policies regarding budgets? A committee will be formed including Nate, Terry, Chet and Corryn. Nate made a motion to form a committee, Chet seconded the motion, motion was approved.

Volunteering fee collection and timeliness

- Fees are collected in Jan/Feb. By May/June for a lot this has been absorbed.
- Possible changes/thoughts:
 - Collect fees later in the year
 - Increase # of hours needed to get more volunteers for bigger events.
 - Coaches and directors get registration fees returned for 1 player per year

All volunteer policies will remain as is. Collecting volunteer fees later would cause a mess. What do we do if they don't pay, etc. We will not be reimbursing registration fees for volunteers and directors on the baseball side it could be approximately 35-50 coaches depending on the year. Coaches who want to do it do it because they are passionate about the game.

ARTICLE 15 BOARD OF DIRECTORS REGULAR MEETINGS The board shall hold regular monthly meetings, without call or notice, throughout the year. If any such date shall fall on a legal holiday, the meeting scheduled for that date shall be held at the same hour on the next ensuing business day that is not a legal holiday. At such regular meetings, the board of directors shall transact all business properly brought before the board. The monthly meetings of the board of directors shall be held at ______ or such other place within the State of Minnesota as the directors may unanimously agree on. At all meetings of the board, a majority of the directors shall be necessary and sufficient to constitute a quorum for the transaction of business, and the act of a majority of the directors present for discussion in person or online, at any meeting at which there is a quorum shall be the act of the board.

Soderville Baseball - Potthoff

- City has put in new pitching mounds and home plates at Soderville and City Park #3. We have also asked for new mound covers
- Surveys were reviewed and there were no surprises
- Season went well. All of our senior league teams placed in the state tournament. MYAS had issues with their tournaments and will be putting in changes for the following years.
- Soderville players have a couple teams participating in MYAS fall ball league
