In consideration of my being permitted by Moorhead Crush Fastpitch to participate in the season, I exercising my own free choice to participate voluntarily in or allowing my child acting as their parent, guardian or representative in the above named activities, and promise to take due care during such participation, hereby release and discharge, indemnify and hold harmless the Board of Governors, executive board, coaches, parents and Moorhead Crush Fastpitch.

Moorhead Crush Fastpitch, and their members, officers, agents, employees, and any other persons or entities acting on their behalf, and the successors assigns for any and all of the aforementioned persons and entities, against all claims, demands, and causes of action whatsoever, either in law or in equity, relating to injury, disability, death or other harm, to person or property or both, arising from my participating in or allowing my child or charge from participating and/or simply being present at the above listed activities.

I consent to the participation in the activities described above, and I fully enter into and agree to the above release from responsibility.
