- Would like to bring in another person to assist with concessions. Ideally a boy's team parent so there is coverage for both tournaments reducing the risk of missing any games

Biggest change was removing all prepared foods (walking tacos, chili, hot dogs, cookies) and sticking with items that were already made (pizza, bbq, subs). Dickey's was slow on Saturday, but sold well on Sunday.
- Cookie Dough Bliss was a huge hit! They said this was their largest tournament by far! We sold just under 550 units, bringing in a profit of just over \$400! For context, Shakopee's girls tournament the weekend prior to ours only sold 350 units...
