Payment Options:

Payment in Full

Payment in full, made by cash, personal check, or money order, will reduce the fees shown above by \$50.00. Payments should be made to AFC Lightning.

Installment Plans

Consists of four (4) installments - The first payment is due at signing date and each additional payment will be made on the 1st day of September, October, and November.

Refund Policy: With the exception of season ending injury or illness as outlined in the Book of Procedures, **AFC Lightning has a no refund policy.**

Payment Default and Late Fees: Members will be notified immediately if a payment is late. Members will have 15 days to update their payment info or reach out to administration for assistance. If the payment is not resolved within the 15 days, a \$15 late fee will be charged.

Financial Aid: AFC Lightning has established a program to provide financial aid to qualifying participants. This program assists players with annual dues and does not cover the cost of uniforms, travel, or tournament fees. The family of each participant is required to volunteer their time to work at AFC's events and activities throughout the playing season. Requests for financial aid will be based on a first come, first served basis and funds are limited each year. Additional information, requirements, and Financial Aid applications can be found on the club's website. **Financial Aid applications are due no later than June 3rd, 2022.**
