

HOPKINS ROYALS RFC (also known as Hopkins Royals Rugby Football Club)

PARTICIPATION CONSENT, ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY AGREEMENT

The undersigned Player and his/her Parent or Guardian hereby grant permission for Player to participate in the activities of Hopkins Royals RFC, a Minnesota non-profit corporation, and will pay program dues for his/her participation.

Assumption of Risk: In consideration of your acceptance of the Player as a participant in Hopkins Royals RFC's program, Player and his/her Parent or Guardian acknowledge and agree that participation in the activities of Hopkins Royals RFC, including, but not limited to, warm-up, practice, matches, training, clinics, travel and social events (referred to herein as the "Activities"), includes participation in rugby, a full-contact sport, and can be hazardous and present a danger to Player, including, without limitation, risk of serious bodily injury, permanent disability, paralysis and death, and that some risks cannot be predicted or controlled. Player and his/her Parent or Guardian consent to Player's participation in the Activities and FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY for any property damage, personal injury, death or disability that may result.

Waiver and Release of Liability: Player and his/her Parent or Guardian hereby release, discharge, hold harmless, indemnify, and covenant not to sue Hopkins Royals RFC, its directors, officers, coaches, volunteers, attorneys, administrators, representatives, agents, and its contracted entities and facilities and the owners and lessors thereof, as well as the City of Hopkins, the District 270 Independent School District, Minnesota Youth Rugby, and the Minnesota Rugby Football Union, and each of their directors, officers, employees, agents, coaches, volunteers, attorneys, administrators, representatives, and agents (collectively, "Releasees"), from any and all claims, liability, causes or actions, and/or demands whatsoever arising out of, incidental to, or connected with the Activities of Hopkins Royals RFC, including, without limitation, any and all damages, loss, personal injury, death or disability suffered by Player and/or his/her Parent or Guardian incidental to, connected with, or arising out of any negligent act or omission of the above mentioned parties or from any other cause.

In accordance with Minnesota law, nothing in this Assumption of Risk, Waiver and Release of Liability Agreement should be construed as assuming any risk, or waiving or releasing any claims Player or his/her Parent/Guardian may have for gross negligence, willful or wanton misconduct, or reckless or intentional acts by or on behalf of Releasees.

No Insurance: I understand and acknowledge that Hopkins Royals RFC, the City of Hopkins, the District 270 Independent School District, Minnesota Youth Rugby, and the Minnesota Rugby Football Union do NOT have medical or health insurance covering Player or his/her Parent or Guardian.
