August 18, 2021

Virtual Meeting via Zoom

- I. Call to order
 - o Attendees: Troy Creurer, Kevin Logan, Sean Allard, Ryan Hayes, John Mousaw, Colleen Logan, Bryan Parker, Mike Sergi, Mandie Mousaw, John Stone (public)
- II. Welcoming remarks - Troy Creurer
 - o For future meetings this dates is great for missing fall sports
- III. Approval of 6/23/21 meeting minutes
 - o Sean motion to approve, Colleen second. Minutes filed.
- IV. Public Comment (5 mins max per person)
 - o John Stone attended, curious about the goalie clinic.
- V. Old Business
 - o Affiliate Skater Discussion - Kevin Logan
 - Table for now and Kevin will send an update to the group for approval
 - o Political signs promoting CMH registration - Ryan Hayes
 - 12 ordered today and will arrive on Thursday
 - Plan to put around the school and various places in the village
 - Will move them around the village throughout the fall
 - o Amazon Smile Program - Sean Allard
 - Troy to talk to Grey and Grey to ensure we don't violate any non-profit rules by joining this program, it does not violate the non-profit status
 - Sean will send out info on the FB page
- VI. 2021-2022 Budget and Team Fee Structure - Brian Parker
 - o Teams included in registration = 14U Bears, 14U Blades, 12U Blades, 12U Bears, 10U Bears, 8U Bears, 6U Bears
 - o Teams not registered = 10U Blades, will only be a tournament team if the numbers can make a team
 - o 10U Bears team may have ~21 skaters, so it may be a balance for one team vs 2 teams but will have to decide once the overall registration numbers come in
 - o Registration will open on 8/19 and will go through mid September





- o Will need to add flyers to handout at schools such as Canton, Hermon Dekalb, E-K, Gouverneur, Heuvelton, Lisbon
- o Will add cub club, free hockey on Saturdays - Johnny Mousaw will help organize
- o Payment per team confirmed and Troy will open registration on 8/19
- o The registration will be a two payment plan

VII. Update on Kevin Smith Sports - Sean Allard

- o Steel store #1 opened and closed by mid July, deliveries coming up at the end of August
- o Steel store #2 to open for the 11U team only and will close on 8/18
- o Blades store opened this morning and store will close on 9/5 and orders to arrive in late September
- o Bears store is ready and will have to decide on when that store will open, Troy and Sean will talk at a later date to decide on a date to open the store
- o Practice jerseys and gloves will have to be added to the stores at a later date

VIII. Ice Schedule - Kevin Logan

- o Clinics (Blades/Bear) ideas & goalie training
 - Blades Clinic
 - Troy to talk to Rusty Gallagher, Northern Zone President to see if girls from another association can participate without an agreement
 - Mike Sergi will be the contact to organize the clinic
 - Age groups 6U - 12U and older girls are available to help as a coach
 - Kevin to put 1 hr per week in the schedule and will start the clinic on week 1 of ice
 - Sean recommends we have pictures to post to the website for clinic and other teams as well
 - Registration will be a separate registration per skater and Troy and Bryan will come up with a proposed cost per skater
 - Bears Clinic
 - Open up to 8U, 10U & 12U clinic for Bears only
 - Steel teams will do their own clinic if they choose





- Kevin to schedule 1 hr/wk for clinic and it will possibly stagger each week between Blades and Bears but more details to be sort out before the next meeting
- Goalie Clinic
 - Craig Siddon would rather work with individual teams vs a clinic format
 - John Stone will run the clinic and would like to use a few skaters from the varsity practices to help with shooting
 - Kevin to schedule 1 hr per week on Wednesday for goalie clinic after varsity boys practice
- o Pavilion Regulations
 - Canton rec director mentioned that masks will probably be required because municipal buildings are requiring masks
 - Locker rooms will be open
 - All of this is subject to change as the CV19 situation continues to evolve
- IX. Concession Stand Update - Troy Creurer
 - o Troy to send in the DOH paperwork
 - o CMH has a person to run the concession stand
 - o Canton rec director is fine with CMH running the concession stand
 - o Sean recommended we could sell stickers through the stand to raise some funds

 - Coaches need to get registered through the CMH website
