- Play up in April vs March, Dugout very good.
- Reconciled cash; \$31,354.75 in the bank account as of 4/30/2023.
- ➤ Will be adding five (5) Steering Committee/DIBS positions.
- > Will be adding one pull-tab seller; looking for daytime positions and evening flexibility.
- Receive a warner letter from the State/Gambling Control Board (GBD); need to report to the CEO, GM, and Treasurer; forgot to send it to the Treasurer; Jim forgot to do that w/the last Treasure change
- ➤ Need vote to approve the June 2023 Budget and Lawful Purpose spending.

*MOTION made by Tom Larson to approve the Budget/Operational Expenses (LG1004) for June 2023, not to exceed \$35K at Quinny's and \$20k at Forster's Dugout (\$45k total); Lawful purpose spending (LG1004) of \$31k in taxes; and \$1,300 (Park Fee) to the City of Mahtomedi. Second by Alex Rogosheske. Unanimous. Motion passes.
