COLORADO SPRINGS ALTITUDE VOLLEYBALL CLUB POLICY:

1. **FINANCIAL COMMITMENT:** When you accept an offer to participate with Colorado Springs Altitude Volleyball Club (CSA, CSAVBC, or the club), you accept the financial obligations for the entire club fee for that season. When teams are comprised, monies immediately go directly into uniforms, tournament entry, and other team and club expenses. By signing this agreement, you agree that you are responsible for your portion of the total season expenses. If your player cannot finish this season for any reason, you are still responsible for your share of the cost incurred by the team, and you agree that CSA is within its rights to collect any unpaid monies due to the club. You understand that if you do not fulfill your financial commitment that your membership may be placed on hold in accordance with Rocky Mountain Region (RMR) Membership on Hold policy. You also understand this may affect your eligibility and the eligibility of other family members associated with CSAVBC.
2. **PAYMENT:** Payments are due on the 5th and are considered **past due** on the 6th. Past due payments may be subject to additional fees/penalties. Any player whose payments are past due may be ineligible to participate in practices or tournaments until the account is current. Alternate payment plans may be requested in writing to the CSA Treasurer.
3. **FINANCIAL ASSISTANCE:** CSA and RMR both offer limited need-based financial assistance. Please visit the RMR website or contact the CSA Club Director for more information.
4. **REFUND POLICY:** Due to our non-profit status and budget requirements, CSA does not offer full refunds. Refunds will not be given to athletes who choose not to play because of conflicts, team assignments, coaching assignments, or individual playing time. Partial refunds due to military PCS (permanent change of station), season-ending injuries, or other extenuating circumstances **MAY** be considered on a case-by-case basis. Any refund request must be submitted in writing, and documentation (e.g., physician’s note, orders) may be required. Decisions on refunds will be at the sole discretion of the CSA Board and only after fees for the season have been paid in their entirety. The initial payment due at signing is non-refundable under any circumstances, and any CSA Board decision shall be final.
5. **PLAYER COMMITMENT:** Players are required to attend all scheduled events for this team to include practices, tourneys, meetings, etc. Communication shall happen well in advance of any deviation from this requirement.

I hereby agree to these provisions as a commitment to my daughter’s participation on a CSA team. I also understand and agree that CSA will impose consequences that affect my family’s participation with CSA and the RMR in the event the obligation I have agreed to herein is not fulfilled. I understand the detailed expenses for my CSA team are available for my review if requested.

I agree to the above commitment to play for CSAVBC for the 2026 season.
