- Mark Stevenson seconded the motion.

- Motion passed unanimously

# **Treasurer: Jeff Strueder**

- Report presented via spreadsheets on overhead projector
  - Changes that could possibly happen current PayPal possibly moving to Sports Engine, trying to streamline for the office. Reporting can be easily downloaded from Sports Engine
    - Current process is to manually pull information from PayPal and then be organized by the Treasurer
    - Fees are mostly equal
    - Tina Tonte is working with her contact to digitize a lot of the reporting
  - o Balance sheet, as requested from previous meeting
    - Provided numbers
    - Reported that we had overpaid the withholding taxes over the last nine years to the total of around \$1000 and refund has been requested.
  - Statement of Activity
    - Where we are getting money from and where we are spending money
    - Provided income by category
    - Broke financials down by individual state tournament
    - Numbers will grow from the duals that are still coming in
    - Women's trips had questions. Listing women's nationals as Fargo because there are other trips that are listed as nationals.
    - Trying to clean up reporting
    - One more camp, hosted by Warren Central, still to be paid.
    - Reporting by tournament as to income and expenses
  - o Fargo Juniors/Cadets are lumped together because they are on same bus, but can be split out if needed.
    - Keith Davison asked for comparison to last year's numbers.
    - Reported that it was pretty close to last year's but we still have some expenditures to pay.
      - Another bus is being added to Fargo, Fargo gear, etc.
  - o Provided sample spreadsheet showing how items will be shown at budget meeting.
    - Should be easier to compare year over year for budgeting.
    - Still needs scholarship information from Linda only outlying issue.

  - Jeff Strueder is working on the schedule. Possibly eating dinner on Saturday night outside of the hotel
  - Has had lots of tournament director questions. Such as how much can we spend? Has directed them to previous budget
  - o Is awaiting USA Wrestling breakdown
  - o In preparation for meeting, listed out the different trips, example for Heartland Duals Jason/Ryan will receive the report in advance that shows income/expenses.
  - Will email income/expenses to them prior to budget meeting for ease in processing budget.
  - Went through the income and expense reports for each state tournament

## **Review of State Series 2018**

#### **Elementary Duals**

- Patt Van Horn felt Elementary State went off without any hitches
- Still sagas with some teams and coaches. Thinks Ryan Parrish has thoughts of how to change some things as people feel that the tournament has lost the feeling of original intent.

## Folkstyle State

- Patt Van Horn stated there were some glitches, such as needing athlete cards and no cell phones.
- Someone took a picture in our weigh in room when no phones were to be in the area.
  - Pat Culp stated a person was arrested in a non-related incident and they found pictures in on their computer from our weigh-in rooms stressing the need for no phones in the room.
  - Patt Van Horn had an issue with weigh-ins, it was announced on the website that wrestlers not be on the property until 4pm because of school requirements. This did go a little better Avon.
  - o Issue at Warren Central as to what we will do with weigh-ins. This is definitely an item we need to resolve.

- Weigh-ins on Saturday went better by not using upstairs rooms. She felt it went fairly smoothly
- o Awards were acceptable to the masses.
- o Saturday went a little log but went pretty well.

# **Freestyle State**

- Patt Van Horn reported that Freestyle went well. Tried to get the stage. Looking for anyone who would be interested in building a stage.
- A stage for 2-day event would be around \$7,000.
- Keith Davison feels this needs to be evaluated.
- Timewise we got out pretty well. Streaming went well.
- IT Issues were on Avon's end dropping ports, etc.

#### **Overall State Tournaments**

- Overall state tournaments went well, looking to improve on Folkstyle state.
- One thing need to look at is tournament directors are not following state guidelines? Need to determine what our response is going to be.
- There were some IT issues that we need to improve upon.
- Pat Culp discussed this issue with Ohio's State Chair at Schoolboy Duals and he recommended that a letter needs to go to the club, outlining the issue, with a copy to Tony Black at USA Wrestling, and they could be told they can no longer sanction tournaments. He feels that is a very serious issue because insurance is voided for facility and volunteers, kids are covered by USA cards.
  - o Can have a ripple effect if a facility is sued.
  - o His recommendations First offense, first notification should let them know rules cannot be violated.
  - o Exhibitions are considered a practice, not part of the tournament.
  - Many tournaments are not requiring USA wrestling card number. Registration can be set-up to require and verify USA card numbers. Grade is automatically included in registration and should not be removed.
  - o Head gear requirement is not always being followed.
  - Need to talk about head pairers and head officials, making sure they are adhering to the rules.
  - o Many people think that since tournaments are run on trackwrestling they don't need head official or head pairer, so the rules aren't necessarily being followed.
  - Some events have gotten away from having trainers, security is recommended and not all are having these. Waivers are not being obtained.
- Patt Van Horn said there have been lots of questions about last chance qualifiers.
  - o Those should count if approved.
- Patt Van Horn feels a form would be nice to receive from tournament directors, providing the names of the head pairer, tournament director, head official and trainer for their tournament.
- Pat Culp brought up that in the past clubs have been hosting Hiway/Myway/USA Wrestling combined tournaments. There have been a couple of tournaments in the state say they will accept both cards as long as sanctioned with both organizations. Nothing can be done to discourage this if it is sanctioned with both organizations.
  - o Ohio has tiered membership for those only wanting to do Folkstyle.
  - Discussions about northern Indiana clubs and working on getting them onboard with USA wrestling, Ft Wayne Carroll had reached out to Pat C asking to coordinate dates due to their low numbers.

- A listing of the proposed changes will be included in the Annual Meeting packets for distribution and review prior to the vote at the Annual Meeting in September

Asked about the cost and she doesn't believe that it will be more than \$250 or \$300 per converter. She is working on obtaining the quotes now.
