AZ Kings Financial Policy and Club Commitment

- 1) I understand that by signing this Agreement, I am making a financial commitment to timely pay for the entire season under the payment plan I have chosen.
- 2) I understand that A late fee of \$75 will be assessed for any late payments (payments after the 1st of the month) and payments that are returned for insufficient funds check/EFT.
- 3) I understand that a non-refundable Commitment fee/deposit of \$1,200 (National teams) or \$1,000 (Platinum teams) is due at tryouts when my child is placed on a team **and if not paid-in-full** the remaining balance will be paid in 4 monthly payments, paid January – April (non-refundable) after your commitment fee.
- 4) I understand that an additional 3% fee will be added to any credit card payment.
- 5) I understand that if my child discontinues participation on her respective AZ Kings team, for any reason before the completion of the scheduled 2020-2021 season, all fees paid are non-refundable AND any remaining balance of fees owed must be paid within 30 days of the discontinuation date.
- 6) Financial obligations not fulfilled will be turned over to collections and all fees/costs of collection including the use of an attorney will be added to my balance. I will also be charged interest at the rate of 10% per annum for any fees not timely paid.
