6. LEVEL REP REPORTS

- a. **Mini-Mite:** n/a

- B. **2022-23 Home Tournament Dates/Times:** dates set. Potential for all Girls' tournaments or C1 vs. C2. Great demand for C tournaments. Biggest issue is ice time, likely would take away home game ice. Changing to a pool play format vs. bracket would allow more flexibility with number of teams can register/play.
