# EMPLOYMENT/ VOLUNTEER AGREEMENT

Employment/Volunteer Agreement, between Thornton Junior Football League Association (the "Company") and \_\_\_\_\_ (the "Employee/Volunteer").

1. For good consideration, the Company employs the Employee/Volunteer on the following terms and conditions.
2. **Term of Employment/Volunteering.** Subject to the provisions for termination set forth below this agreement will begin on January 1, 2015, and continue through December 31, 2015 unless sooner terminated.
3. **Salary.** The company shall offer **NO PAY** to its Board members, Coaches and or any other Volunteers. You are acting in this capacity with full knowledge of this fact.
4. **Duties and Position.** The Company accepts the Employee/Volunteer in the capacity of Volunteer Coach. The Employee/Volunteer duties may be reasonably modified at the Company's discretion from time to time.
5. **Confidentiality of Proprietary Information.** Employee/Volunteer agrees, during or after the term of this employment/volunteer, not to reveal confidential information, or trade secrets to any person, firm, corporation, or entity. Should Employee/Volunteer reveal or threaten to reveal this information, the Company shall be entitled to an injunction restraining the Employee/Volunteer from disclosing same, or from rendering any services to any entity to whom said information has been or is threatened to be disclosed, the right to secure an injunction is not exclusive, and the Company may pursue any other remedies it has against the Employee/Volunteer for a breach or threatened breach of this condition, including the recovery of damages from the Employee/Volunteer. For clarification any and all information in any format that the Employee/Volunteer may obtain from the Company, belongs to the Company and must be surrendered upon request. This information will not and can not be used in any other capacity other than that set forth by the board of the Company.
6. **Termination of Agreement.** Without cause, the Company may terminate this agreement and the Employee/Volunteer at any time upon 1 days' written notice to the Employee/Volunteer. Pursuant to the TJFL rulebook.
7. **Assistance in Litigation.** Employee/Volunteer shall upon reasonable notice, furnish such information and proper assistance to the Company as it may reasonably require in connection with any litigation in which it is, or may become, a party either during or after employment/volunteering.
8. **Effect of Prior Agreements.** This Agreement supersedes any prior agreement between the Company or any predecessor of the Company and the Employee/Volunteer.
9. **Settlement by Arbitration.** Any claim or controversy that arises out of or relates to this agreement, or the breach of it, shall be settled by arbitration in accordance with the rules of the American Arbitration Association. Judgment upon the award rendered may be entered in any court with jurisdiction.
10. **Limited Effect of Waiver by Company.** Should Company waive breach of any provision of this agreement by the Employee/Volunteer, that waiver will not operate or be construed as a waiver of further breach by the Employee/Volunteer.
11. **Oral Modifications Not Binding.** This instrument is the entire agreement of the Company and the Employee/Volunteer. Oral changes have no effect. It may be altered only by a written agreement signed by the party against whom enforcement of any waiver, change, modification, extension, or discharge is sought.
