Helena 14U-18U - Combined House Tournament (Non-Checking) FORMAT AND RULES March 9th and 10th 2024

This document describes the format and rules associated with the Helena 14U-18U-Combined House Tournament. All participants need to be USA Hockey registered and credentials will be checked. Coaches should read this document carefully and ensure that they, as well as their team, understand the rules of this tournament. The tournament is a non-body checking, House/recreational division tournament and is open to house level players. "B" teams may be considered, but only with approval from the Tournament Director. Teams may be comprised of combined 14U, 16U and 18U players, but teams are anticipated to average to 14U age divisions. Contact Tournament Director with questions. The Tournament Director will provide the tournament schedule. Teams will be competing in three or four games over two days depending on standings. Final team standings will be determined and points will be awarded in accordance with the following system.

TEAM SCORING SYSTEM

- 2 points for a win
- 1 point for a tie
- 0 points for a loss

TIE BREAKERS

If two or more teams have an equal number of points, their positions in the standings shall be determined by the following tie-breaking formulas.

- 1) Head to Head
- 2) Goals scored against, the lower the better.
- 3) Penalty Time in Minutes, the lower the better.
- 4) Coin Toss

CHAMPIONSHIP

The first and second seeded teams will play a final, championship game.

TEAM COMPOSITION

House level 14U/16U/18U players welcome. Teams are anticipated/encouraged to have an average age of 14U, but some variation may exist.

PLAYING AND GAME RULES

This is a *no body checking tournament*. USA Hockey Rules and Regulations govern all games except as modified here. All teams must be registered and rostered with USA Hockey. The games will be full ice. Home team as listed first on the schedule should wear dark jerseys and the visitors will wear light jerseys. Teams should bring both sets of their jerseys. Teams must be ready to take the ice immediately after the Zamboni doors have closed, unless directed otherwise by tournament officials. In case the games are running ahead of schedule, teams

should be ready to take the ice up to 15 minutes early. There will be a brief warm-up period that starts immediately after the Zamboni doors are closed and the referee and/or linesmen are on the ice. NO TEAMS ARE ALLOWED ON THE ICE UNTIL DIRECTED BY THE OFFICIALS. Each team is given 1 minutes between periods unless otherwise directed by tournament officials.

Time-outs: One Time-out will be allowed per team, per game and may be used during regulation play only. Time-outs will be one minute in duration.

Game Length: Every effort will be made to ensure game slots will be *no less than* 45 minutes and consist of 13-minute <u>run time</u> periods. Minor penalties will be 3 minutes, majors will be 6. Except for the Championship game, tie games will end at the end of the third period, each team earning one point. **Tournament Director may make** *uniform* **changes to tournament game length based on the number of teams participating and available ice time.**

Mercy Rule: The scoreboard will not show a differential of greater than five goals.

CHAMPIONSHIP TIE-BREAKER

- 1) A 5 minute, 5-on-5 "Sudden Death" overtime period will be played. The first team to score will be the winner. The teams will not change ends. If tied at the end of the "Sudden Death" overtime period:
- 2) A 5-player shootout shall occur. The team with the most goals during the shootout will be the winner of the game. Five different players must shoot for each team. If a player is in the penalty box when the shootout begins, he/she cannot participate in the shootout. Every player on the team (excluding goalies) must shoot before you can use a shooter for a second time in the shootout.
- 3) If the teams remain tied at the end of the first shootout:
- 4) A "Sudden Death" shootout will be conducted

CREDENTIALS CHECK

Team managers or coaches must check-in with the Tournament Director before the team's first game. All teams must be registered and rostered with USA Hockey. All team rosters will be checked before a team's first game and any players and coaches not on official roster will not be allowed to participate. All on-ice officials are currently registered and in good standing with USA Hockey.

LOCKER ROOMS

Only USA Hockey approved coaches, managers, and locker room monitors are allowed in locker rooms with players. Teams are required to vacate the locker room within 20 minutes of a game ending. Gear cannot be left at the rink when a team is not playing. Teams are required to leave their locker room clean and damage free. Teams will be accountable for any damage to the facility. It is the team's responsibility to ensure their locker room is secure, as the tournament and rink are not responsible for lost/stolen items.

PROTESTS

All protests will be heard by the protest committee. This committee will consist of the Tournament Director and tournament committee. No judgement call by an official will be heard for a protest, meaning the referees' calls on the ice are final.

Additional Tournament Rules

- 1. Sportsmanship Fighting, abusive behavior, unsportsmanlike conduct by players, coaches, or parents will not be tolerated. Such behaviors could result in immediate ejection from the tournament. The Tournament Director has the final say in such matters.
- 2. Only four coaches are allowed on the bench during a game.
- 3. No refunds for tournament entry fees.
- 4. All teams must provide their own penalty box worker (must by at least 18 years of age).
