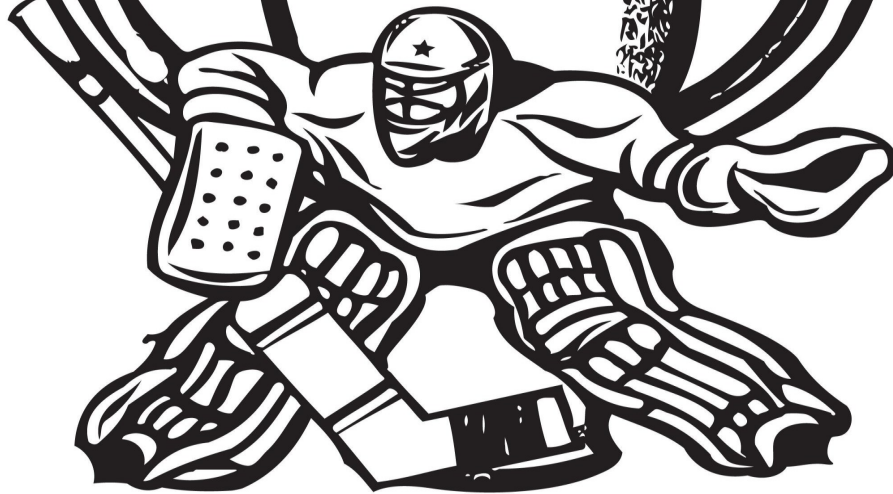

- **Facilities** Games will be played at the Skatium in Skokie
- **Format** Four-team Round-robin format, plus Championship & Consolation playoff games—four games guaranteed.
- **Games** 5 minute pre-game warm-up.
11-minute stop time periods.
1:30 minute minor penalties.
3-round shootout (if necessary)
*In the Championship Games a 5-minute sudden death over time shall occur before a 3- round shootout.
- **Teams** 2018-19 full season house teams only accepted. AHAI Certified rosters must be submitted along with team application form.
- **Players** All players must be a 2018-19 USA Hockey registered house league player who played this season for the same team which is being represented in the tournament. No specially formed tournament teams allowed.
- **Trophies** Team Trophies & Individual Trophies will be awarded to Champions and Runner-Ups at the conclusion of each Division's Championship Game.
