2024-2025 SAHA Tier 1 Committee Report

- ► The Tier I Committee is responsible for the annual review and approval of applications for Tier I program status
- The Committee considers the requirements of the SAHA Affiliate Guide as well as the USA Hockey Annual Guide when reviewing applications
- ► The Committee must make a timely review and determination on applications in compliance with the deadlines listed in the SAHA Bylaws.
- Decisions of the Tier I Committee may be applealed to the Affiliate Board of Directors

2024-2025 SAHA Tier 1 Committee Report (cont.)

- The Tier I Committee received two applications for the Tier I status for the 2024-25 season
 - The Nashville Jr. Predators renewal application was approved for the 2025-26 Season.
 - The Jr. Preds will focus on a Nashville centric model for 2025-26 and going forward
 - The Southeast Blades application was approved for the 2025-26 Season for a limited number of teams
- USA Hockey is conducting an extensive review of Tier I hockey, and many changes are expected in the coming years

- Tier I applications are due each year no later than August 1st for the season beginning September 1st of the following year

- Southern Youth Travel Hockey League had a very successful 2024-25 season.
- Between our standard league (SYTHL) and our elite league (SESCL), we had 92 teams participate.
- We had 10 teams qualify for the USA Hockey Nationals and all teams represented SYTHL and SAHA very well.
- We are currently planning the upcoming 2025-26 season now and we have expectations of a great season

Player Development

- SAHA had 25 players participate at SE District Player Development Camp
 - 5 players advancing to National Camp
 - ▶ 2 goalies chosen for the 16/17 National Camp
 - ▶ 8 players selected for Multidistrict Camp
 - ▶ Additional nominations are needed for the 12/13 Camp
- 2026 Girls District Player Development Camp will be hosted by SAHA in Nashville

Program Highlights

- Nashville Jr. Predators:
 - ▶ Rostered three AA NTB girls teams (U14-U19) for the 2024-25 season, with strong SAHA representation
 - ▶ U14: 78% SAHA based
 - ▶ U16: 100% SAHA based
 - ▶ U19: 89% SAHA based
 - ▶ All three teams advanced to Nationals in 2025. The U19 team won the SE District Championship, while the U14 & U16 teams were runner-ups.

Program Highlights (cont.)

- Harpeth Hall (Nashville)
 - ► Continues to have the only all-girls team fully organized & supported by a school.
 - ► Granted varsity status this year with 25 girls participating in the 2024-25 season
- ▶ Tennessee Wolverines
 - ► Engaged 95 players, coaches and volunteers across 3 teams with 60 players participating.
 - ► Also hosted 8 "Free Girls" hockey sessions across Tennessee

Program Highlights (cont.)

- Nashville Warriors
 - Continued growth in U8-U12 girls playing on AA boys teams as a development path to Jr. Predators
 - ► A new U6 program will launch for the 2025-26 season
- Knoxville Lady Wild
 - ► Hosting U8 and U10/12 teams with 30 girls participating
 - ► Competed in 4 all-girls tournaments and holds two girls-only practices per month

Program Highlights (cont.)

- Atlanta Jr. Thrashers
 - Fielded a U12/14 team of 14 players in the SGHL
 - Offered weekly practices for U10/14 players, including goalie tryouts to boost participation
 - ► Hosted the SGHL Championship at Duluth Ice Forum
- Huntsville
 - ► Ran girls-only clinics and 3 on 3 sessions
 - ► The Little Preds program included 35 girls, with a total of 119 girls (U6-U16) and 18 adult women participating

Nashville Predators Hosted Events

- ► Hosted the 4th annual SMASHVILLE Women's Collegiate Hockey Showcase over the Thanksgiving weekend
 - ► Featured 32 youth teams across six divisions from 12 states and 11 Ontario programs
- ► The 5th annual tournament is scheduled for this November the following teams confirmed to participate
 - Wisconsin
 - Mercyhurst
 - Stonehill

NCAA Hockey

- Tennessee State University
 - Moving the launch of its NCAA Division I men's hockey team back by one season to 2026-27
 - TSU will continue to prepare for the 2026-27 season with community engagement, donor initiatives, and program development
- "Working closely with the NHL and the Predators, we agree that an additional year will provide the program with the time and resources it needs to launch at full strength and with longterm financial success in mind,"
 - TSU Interim President Dwayne Tucker said.

 - Press release July 10, 2025

PROGRAM PROPOSAL Ladd Foundation

June 9, 2025

Description

- ▶ 1616 is a nonprofit, virtual program designed to support coach and player well-being development on and off the ice. The program uses real stories from professional players and is about building competence, confidence, connection and character.
- ▶ Backed by research and real-world results, 1616 gives kids, hockey parents and coaches tools they need to grow and face challenges head-on. Participants will learn how to take on the attitude and mindset of the buffalo, to face life's inevitable storms, with courage and resilience.

Description (cont.)

▶ 1616 is a 10-week, self-paced, virtual program experience that runs from October 2025 to March 2026 (teams can select a start date anytime in that window). 1616 is designed for hockey teams with players ages 10 through 13 along with their parents and coaches, but individual families as well as younger or older players can also sign up. Content is delivered virtually and requires just 20 minutes a week to complete at no cost.

Objectives

- Establish a Southern Amateur Hockey Association (SAHA) 1616 Chair
- Establish and train a 1616 facilitator at each association
- Attract new registrations across SAHA's ~30 associations
- Work with USA Hockey to consider 1616 as a 3rd party continuing education opportunity

New LMS System For Officials (like coaches)

- Must complete online Membership Registration
- Online Modules (time commitment varies by Level (1-4)
- Online open book exam (Number of questions varies by level)
- 3-hour seminar over Zoom (all USA Instructors following the same curriculum)
- Must complete SafeSport training (if at least 17 y.o.)
- Must complete and maintain a USA Hockey sanctioned criminal Background Screen if 18(+) years old on June 1, 2025

Instruction Emphasis

- Standards of Play and consistency
- Player Safety
- Communication and De-escalation
- Zero Tolerance

Equipment:

- Goal Keepers: Requires HECC certified neck laceration protectors for all Youth, Girls and High School goalkeepers. With note allowing BNQ certified NLP's for 2025-26 and 2026-27 seasons.
- Skaters: Requires HECC certified neck laceration protectors for all Youth, Girls and High School players. With note allowing BNQ certified NLP's for 2025-26 and 2026-27 seasons.
- Equipment Measurement: Mandates bench minor penalty for team who challenge a mouthpiece and the challenge is not verified.
- Electronic Devices: Adds cameras and microphones to list of devices prohibited to be worn by a player during games. Any violation results in a misconduct penalty

PLAYING RULES:

- Abuse of Officials and Other Misconduct: Mandates game misconduct penalty to player or coach who uses obscene, profane or abusive language to any person after the game.
- Delaying the Game: Removes mandatory minor penalty to a goalkeeper who accidentally shoots the puck out of the playing area.
- Face-off Locations: Clarifies that stoppages caused by the attacking team in the attacking zone shall result in a neutral zone face-off.

PLAYING RULES (Continued):

- Icing the Puck: Allows teams at the Youth 15-Only and above, and Girls 16U and above, to ice the puck while playing shorthanded.
- Icing the Puck: Requires center-ice face-off location if game officials err in calling icing.
- Kicking Opponent or Puck: Clarifies play must be immediately stopped and resulting face-off locations for attempted kickshot.
- Kneeing: Adds mandatory misconduct to any minor penalty assessed for kneeing an opponent.

PLAYING RULES (Continued):

- Offside: Allows teams at the Youth 15-Only and above, and Girls 16U and above, to play with Delayed/Tag-up Offsides.
- Offside: Removes automatic whistle for shooting the puck into the attacking end zone "on net" with attacking players still in the end zone.
- Puck Out of Bounds or Unplayable: Requires a face-off located in the same zone the puck was located in if the puck leaves the playing surface or becomes unplayable.
- Refusal to Start Play: Adds second warning to team before suspending the game for refusal to start play.

Season Recap

- ► There were 19 Match Penalties reported to SAHA in the 2024-25 Season (September 2024-July 1st, 2025
- ▶ 10 of the Match Penalties were of the 601(e) variety
- ▶ 10 Match Penalties were assessed to youth players; 9 assessed to adults

Disciplinary Dispute Resolution Report (cont.)

- ► Things to Remember Heading into the 2025-26 Season
 - ► All 601(e) Match Penalties will be managed by SAHA as mandated by USA Hockey. Supplemental discipline may be levied by the local association <u>AFTER</u> SAHA has made a ruling and it's final
 - ► When dealing with all disciplinary matters, following protocol outlined in Bylaw 10 is mandated by USA Hockey

Disciplinary Dispute Resolution Report (cont.)

- ▶ When assessing suspensions, the game the infraction occurs in does not count as the first game of the suspension. EXAMPLES:
 - ► The penalty occurred before the players first shift, so he missed the entire game
 - ► This does not qualify as a suspension when assessing disciplinary action. Suspensions commence with the next regular scheduled game at the time of the incident.
 - Associations should refer to the recommended suspensions in the USA Hockey Rule Book

Following the Bylaw 10 Process

- ➤ The purpose of Bylaw 10 is to comply with our NGB obligations, but also to provide a method to resolve disputes that will avoid lawsuits.
- Courts will defer to the governance and disciplinary decisions of private organizations so long as they follow their rules.
- Courts will interfere in that process and decide the issues themselves when an organization issues discipline or determines a party's rights without following the organization's rules.



Bylaw 10 Scope

- Bylaw 10 applies...
 - When issuing discipline to a player, coach, official, team or program.
 - When an affiliate or organization issues a decision that affects a party's eligibility to participate or their membership in an organization.
 - Examples include an affiliate denying Tier I status or denying a proposed club membership in the Affiliate, a league denying a club admission into the league, or denying a player waiver to move between clubs.



Bylaw 10 Hearing Requirements

When dealing with a matter under Bylaw 10, it is important to be familiar with the requirements for such things as:

- ➤ Notice required for the hearing
- > Reasonably disinterested and impartial hearing panel
- > Time to hold the hearing
- > Rules for the hearing (e.g., discovery, attorney participation)
- ➤ Burden of Proof
- > What must be in the decision



Appeals

- Any person suspended or otherwise disciplined may appeal that suspension after the hearing or failure to have a hearing.
- The Appeal Authority is in most cases either (a) the entire Board of a state association or Board of an Affiliate, or (c) a designated committee of a state association or Affiliate.
- For *Disciplinary Actions*, the party may then appeal to the National Appeal Committee.
- For Administrative Actions, the final appeal is to the Affiliate, but Arbitration may be available.



Application of these Principles

- ➤ Each local league, association and organization and each Affiliate *must* abide by the procedures set forth in Bylaw 10 when imposing suspensions or other discipline.
- ➤ Each local league, association and organization and each Affiliate should have a committee, or persons that could be named to serve on a committee, to ensure that there are at least 3 reasonably disinterested and impartial persons to hear each matter.
- Each Affiliate should be prepared to determine an appeal (either by holding a hearing or through written submissions) within 30 days of the date the parties have submitted their statements;
- Affiliates should consider appointing an appeals committee to hear appeals in order to meet the required timelines.



Reporting of SafeSport Matters

- Any adult that is authorized by USA Hockey, a member of USA Hockey, or any Member Program, to interact with a Minor or amateur athlete at a Facility or at any event sanctioned USA Hockey or a Member Program, is considered a mandatory reporter.
- ➤ If an Adult Participant reasonably suspects that an incident(s) of Sexual Misconduct has occurred, they must immediately (no later than 24 hours) report the incident(s) to the Center and to applicable law enforcement authorities.
- An adult Participant's failure to report as set forth above may subject such person to disciplinary action by the Center and/or USA Hockey.



Sexual Misconduct or Child Abuse

- Sexual misconduct is broadly defined and includes sexual or gender related harassment, sending sexualized messages over electronic media, sexual gestures, pornography, an adult exposing private areas, etc.
- Child abuse can include any time an adult physically strikes a child or puts them in danger.
- ➤ You should *never attempt to evaluate the credibility or validity* of Child Abuse or Sexual Misconduct allegations as a condition for reporting to appropriate law enforcement authorities or the Center.



Reviewing Allegations of Hateful or Discriminatory Language or Conduct

- > Seeing a significant increase in these situations at beginning of the season.
- Can involve discriminatory conduct that involves racism, gender or gender expression, sexual orientation, religion, disability, etc.
- Can involve conduct during a game, among teammates or in electronic or social media.
- > All must be investigated and handled at Affiliate level not local clubs.
- ➤ Must be investigated, and if determined to *more likely than not to have occurred* (50.1%), then the appropriate penalty should be assessed.
- > Standard penalty guidelines indicate 3-5 game suspension, with a minimum of 3.
