I voluntarily elect or accept and solely assume all risk of damages, injury, including death, incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member or observer during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play; 2.) I release, discharge and agree not to sue the team and/or league designated below or any owner or lessee of fields on which softball is played or practiced by my team or USA Softball, their owners, officers, umpires, agents, servants, associations, employees, or any person or entity connected with the team, league, field or USA Softball for any claim, damages, costs, or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause, including, but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released. Pick-Up Players

2024 8U C TOURNAMENT RULES CHAMPIONSHIP PLAY

(Effective for the 2024 season and thereafter, until amended)

The current USA Official Rules of Softball and the Northern California Rules of Regulations shall be enforced at this event.

1. **Game Time:** Will be 6 innings or 1 hour, 10 minutes, whichever occurs first.
 - A. The Champions game (and the "if necessary" game) shall have a time limit of 1 hour, 20 minutes.

RULES & REGULATIONS (except 8U)

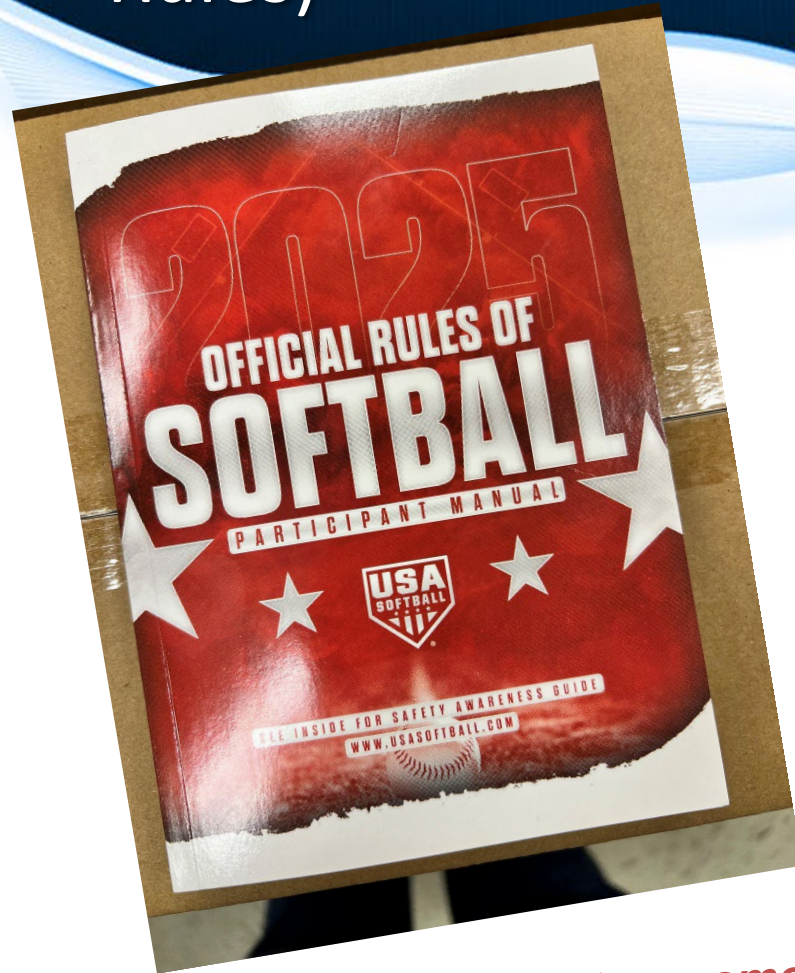
1. All games will be played under current USA Softball Rules, except where modified in these supplemental rules.
2. **Managers are responsible for the conduct of their respective teams and fans.** Any players, coaches, parents, spectators or fans that use profanity, incite trouble, promote poor sportsmanship, physical retaliation or bring into question the integrity of coaches, players, umpires or tournament staff will be removed from the complex and may be removed for the whole tournament if warranted. No warnings will be given. Additionally, destruction or abuse by guests of hotel/motel property could subject the team to suspension or other appropriate action.

PLEASE NOTE - Umpires (during games) and/or the Tournament Director (or his/her representative) shall have the responsibility of ejecting coaches, players, or spectators for abusive language or other acts that are contrary to the objectives and purposes of USA Softball. A warning for the first offense **MAY** be issued at the Umpire's/Official's discretion. The second offense by coaches or players **SHALL** result in ejection of the responsible individual(s). Second and subsequent offenses by a spectator shall result in ejection of the (1) Head Coach, (2) coaching staff and (3) players. Anyone who is ejected from a game must leave the facility for the remainder of the game. The severity of the ejection will dictate whether the person will be allowed to return for the remainder of the tournament.

Manager Responsibility - If the Tournament Schedule is delayed, it shall be the responsibility of each manager to contact the Tournament Director for possible game time and/or field changes.

3. **Championship Roster limited to 20 players.** All players' parents or legal guardians must sign the roster. (If player is 18 years or older, player can sign the roster). Verification of birth date for each player must be available. Players should always have their Photo ID Card with them. If not adhered to, players will be removed from the roster as per current USA Softball Code.

“B / C” TIME LIMITS AND RUN RULES

- ▶ Time Limit for 10U, 12U, & 14U:
- ▶ 1:30 minutes and finish the inning. If the game is tied after the time limit has expired, the Tie Breaker Rule goes into effect. Time begins with the first warm-up pitch legal or illegal.
- ▶ 10U Championship Game: 2-hour time limit.
- ▶ 12U, 14U Championship Game: No time limit.
- ▶ Run Ahead Rule: 15 after 3 innings / 12 after 4 innings / 8 after 5 innings.
- ▶ Tie-Breaker Rule after 7 innings (time permitting) or Time Limit.

"8 C" TIME LIMITS AND RUN RULES

Time Limit for 8U:

- 1:15 hour and finish the inning. If the game is tied after the time limit has expired, the Tie Breaker Rule goes into effect. Time begins with the first warm-up pitch.
- Run Ahead Rule: 15 runs after three innings, 12 runs after four innings or 8 runs after five innings.
- Tie-Breaker Rule after 6 innings (time permitting) or *Time Limit*.
- Championship game will be played with a time limit of 1:20 hour or 6 innings whichever is reached first.

OTHER TOURNAMENT RULES

- ▶ NOCSAE approved Batting Helmets and Face Mask/Guard for Batting Helmets – *check your batting helmets for missing screws!*
- ▶ Game time is forfeit time!!!!
- ▶ Base Umpire will be the Official Timekeeper
- ▶ No infield practice (*Use foul territory only.*)
- ▶ Courtesy Runner for pitcher/catcher only.
- ▶ Chin Straps: **If used**, must be serviceable and worn properly.
- ▶ Flex/DP: Flex is the last entry listed on the Line-Up Card.

- ▶ Coin flip for home team by the umpire on the field.

- ▶ Team warm ups behind homerun fences or open grass area
- ▶ Electronic ACE and Player Cards checked on the field.
- ▶ Equipment Inspections – Equipment removed from play cannot be reclaimed until your team has completed all play in the tournament. *(policy included in managers packet)*
- ▶ Bat Testing Machine *(random use throughout the tournament).*
- ▶ No infield foul area practice when field prep crew is working.
- ▶ No flash photography (directed at players).
