

## **PAHA Board Meeting September 13, 2021**

Molly called the meeting to order at 7:01pm

Shaun motioned to approve the 8/9 minutes. Justin seconded. Minutes approved.

### **Treasurer's Report:**

Molly reached out to the families with overdue ice bills from 2020. Families were told they can't play this season until prior ice bills have been paid off. December 31<sup>st</sup> players will be de-rostered if their ice bill is not paid for the current season.

### **Old Business:**

Nets are an issue. Rink is allowing us to use the nets for now. We are tabling the nets issue as this was not included in the Petoskey Ice Rink contract.

## **New Business:**

### ***Registration Update - Molly***

Currently we have 56 total PAHA players signed up (27 of these are on the travel teams). Sarah will advertise and send flyers to area schools to help increase our numbers, as well as update Facebook and the website.

### ***Jersey Request - Molly***

Bantam A team would like to purchase new jerseys (Piranhas). They are paying for these and the name has already been determined. Shaun motioned to approve the jerseys with "Petoskey" or a "P" as part of the Piranha name. Molly must abstain due to conflict of interest. Justin seconded. Motion passes 7-0. Name passes, but presentation of jersey must be shown to board before final approval. Board will vote through email.

### ***Communications Update – Molly/Sarah***

Website is currently being updated on all pages. Sarah will work on continuing to update as well as create a packet of information for new families. Sarah will advertise on Facebook and get registration information out to area schools in their weekly newsletters.

Learn to Skate will be coming this fall. Elizabeth will get the sign-up link and information for us. Sarah will post it on the website. Anne will train players and the board will provide \$3000 to help train players as listed in the budget. Catheryn indicated we have about a dozen sets of rental gear for players in need.

Little Wings program was asked about and we have no information yet from the rink on the program. Elizabeth will inquire with Fedor.

### ***Fundraising Update - Julianne***

Julianne would like to do a Buffalo Wild Wings PAHA overall fundraiser in the fall. More details will be coming from her on this. Wreath sales will continue and will off-set individual ice bills. Tillie's Tafel was presented as a way for players to receive 40% off their ice bills. Sponsorships will still be available for players to use toward their ice bills, but there will be no banner or t-shirts this year. Sarah will work with Julianne to update the fundraising information.
