New Business/Member Feedback:

Opening Comments

Recap of the January 2019 meeting minutes with the members, prior to the approval.

Budget:

- Reviewed budget, \$198K in revenue/gross sales for Quinny's; \$62K in revenue/gross sales Dugout/Forester's; Total for both locations = \$260K; \$213K paid out in prizes. Net deposit, \$48K.
- As of February 2020 we are doing well; numbers equal to Lion's numbers for both paper and e-tabs; currently have over \$61,177.72 on hand.
- Tax return and LG1000A were on hand for January for anyone to review.
- > Loan repayment; paid back \$17.5K of the \$30K to date; given \$44k to the association to date.
- * **MOTION** made by Mikalynn Hauer to approve the Operational Expenses and lawful purpose spending (LG1004) for March 2020 not to exceed \$20,000 per location (40k total) and the loan repayment of \$2,500 for each location. Second by Kelly Reagan. Unanimous. Motion passes.

Gambling Report:

- ➤ Pull Tabs Dugout sales continue to underperform; losing \$3-4K per month; moved pull-tabs paper the bar; that was a bust. Will try machine pull tabs next. Continue with Bingo, breaking even. Tony Chesek, Gambling Committee member; looking for a new bar.
- Discussions in doing a mailer/postcard; sent to all members; advising of how much Charitable Gambling has raised and given back to the association; e-mail blast communications as well.

- ➤ Bingo Summer Party; to be held at the Dugout; cross promo w/another youth sport, Lacrosse.
- > January 2020 Profit \$11,164.75 for Quinny's, (\$83) Loss for the Dugout
