- a) Received three AEDS (Stryker Physio CR2) on 07/13/2023.
- b) First was given to 14U Boys head coach. Remaining would be for 12U and 14U girls (two 14U girl teams; however, they typically practice back-to-back and could hand off for games). Due to risk/statistics, 12-14U age group is priority, and boys > girls (due to nature of play and statistics).
