FINANCIAL REPORT - JERRY ASHBY

profit of approximately \$5400. The Board had various questions and then moves forward with the 2018-2019 Budget.

COMMISSIONERS REPORT

Board Appointed Position open for Treasurer

5 new clubs have joined the Region. Going from 76 to 65. There is a \$50 fee for existing clubs to license. \$150 for all new clubs that start this year.

Tryout Memberships

It is the responsibility of each club to prove that each athlete that walks in the door has a USA Volleyball Tryout Membership. Clubs would be smart to email a list of what tryout participants need to bring to tryouts, including copy of their \$5 USAV Membership Card. A list of current tryout members will not be sent to clubs this year before tryouts, it will instead be the responsibility of the club for liability sake.

Parent education on tryouts will be launched on the website soon. It's important that coaches, parents, and players know how this new tryout process will work.

Staff's to Begin a Rotating Shift

Going forward into club season, Cindy, Robyn, and Dragan will set up an on-call system within the office staff so that they will be able to work on the weekends attending tournaments and also be sure that someone is in the office during regular hours in the week.

Complaint Process

Cindy wanted to make the Complaint Process page in the Junior Manual very systematic so that a organized process is in place and followed. Complaints will fall into a category of either: Sexual, Physical, or Emotional misconduct. Robyn will assess which category each complaint goes to Sexual - goes immediately to SafeSport and updates will go to Cindy.

Physical and emotional will go to Cindy and Robyn for review and then dispersed back to the Club Directors. Cindy will investigate anything that she feels the club and member are unable to work out on their own.

Cindy explained changes and aspects of the new Complaint Process that has been updated and added to the Junior Division Manual. The Board reviewed Cindy's Complaint Process.

The Board asked that Cindy add complaint forms to the Website.

The Board asked that Cindy makes it clear that members, coaches, and directors should look at the entire Manual as a completely revised document instead of pointing to some areas since most areas have been revised.

A Violation Report Form is when a club may be in the wrong and Cindy will open an investigation. The Commissioner is trying to give people tools on how to file a report so Cindy can better evaluate and investigate a problem, officially.

Junior Advisory Board (JAB)

Dragan has formed the JAB and intends to have meetings through Zoom online conference calling.

NEW BUSINESS

The question came to the Board regarding the Letter of Commitment. The question is asking if a club has to put a player on a specific team or club. The Board discussed the intentions of the commitment and the Board feels the form just wants the club to specify if the player made the club but they do not have to clarify on the form which team the athlete will be on at the time of the 72 hour offer unless the club would like to disclose that information for the player.
