## 2025-2026 FINANCIAL DISCLOSURE & PROGRAM INFORMATION



The following Financial Disclosure and Program Information is hereby provided pursuant to the "Tier II Program Disclosure Requirements" as set forth on Page 19 of the TAHA Guidebook/Rulebook and must be finalized seven (7) days prior to the commencement of the 2025-2026 season tryouts.

### FINANCIAL DISCLOSURES

#### Team Administration Fees

(1) The amount to be paid to the organization for making the team, which generally covers the cost of ice, coach's salary, on-ice officials, scrimmages, and off-ice trainings. Generally, the amount shall reflect all monies collected for administration fees at contract signing.

#### Team Coaching Fees

(2) The amount to be paid to the organization to cover the Coach's travel expenses for tournaments and overnight stays.

#### Initial Tournament Fees

(3) The amount to be paid to the organization to cover the initial tournament entry fees for each team. If the actual amount of tournament entry fees exceeds the initial deposit, then Players will receive a "cash call" (see below) to cover the additional fees.

#### Required Apparel

(4) The amount to be paid to the organization or its vendors to purchase all required uniform and spiritwear items. These items may include but are not limited to, jerseys, socks, shells, wind suits, warm up apparel, polos, bags, and any other items required to be purchased through the organization or its desired vendor. The full amount to be paid by a new player must be disclosed, but an organization may note if the cost will be lower for returning players who may use gear from previous years.

**Team Fees**

(5) The maximum amount to be paid in team fees, which are amounts paid to the organization or to the team to cover any items not covered by the association fees, coaching fees, and initial tournament fees, including but not limited to, coach or team official travel, additional tournament fees, on-ice officials costs, locker room fees, additional ice fees, and team parties or functions. The amount shall also include any team fees not required to be paid by the organizations but that are made mandatory by a majority vote of the team members or their families.

**Type & Target Frequency of Practices**

(1) Describe the amount of ice practices that the team will receive from the organization. This can be described as the minimum hours of on-ice practices the team will receive during the season or by providing the minimum number of practices the team will receive along with the length of such practices. Only the minimum amount of ice to be provided may be included. Organizations may not include language in their disclosure that the team may or will receive additional ice in addition to the stated minimum amount and shall not make such statements orally. Organizations may include in this disclosure ice that is used by a team for scrimmages or similar events so long as the team is not required to pay additional amounts to the organization or rink to purchase the ice. Ice used for league games and tournament games shall not be included in this amount.
