 - c. Bishop McGuinness asked for \$2000 for help with the cost on a volleyball net system for the West gym. **Motioned by Michael M. and seconded by Robert, all approved.**
 - d. Bishop McGuinness asked \$2100 for a new timing system for the track. Enduro is no longer around. Instead of a grant we are going to budget a \$700 rental fee from the track money to be given to McGuinness for the next 3 years. **Motioned by Michael M. and seconded by Aaron, all approved.**
